Explain: **There are 5 wetlands in the project area; however, this JD is only for wetlands labeled Wetland B, C, D and E on the attached figures labeled MVP-2015-03555-LMG Page 1 of 2 through Page 2 of 2. These wetlands are depressional basins and do not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries, as confirmed in the Woodbury Costco Site Wetland Delineation Report dated October 2015. These wetlands are surrounded by upland, and have no swales, pipes or other means to connect them to waters of the U.S. (WOUS). We have determined that these wetlands are isolated depressions and not a waters of the U.S.**

The waterbodies do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. The wetlands do not have an ecological connection to other waters within the review area. The waterbodies were determined to not be jurisdictional under the CWA.

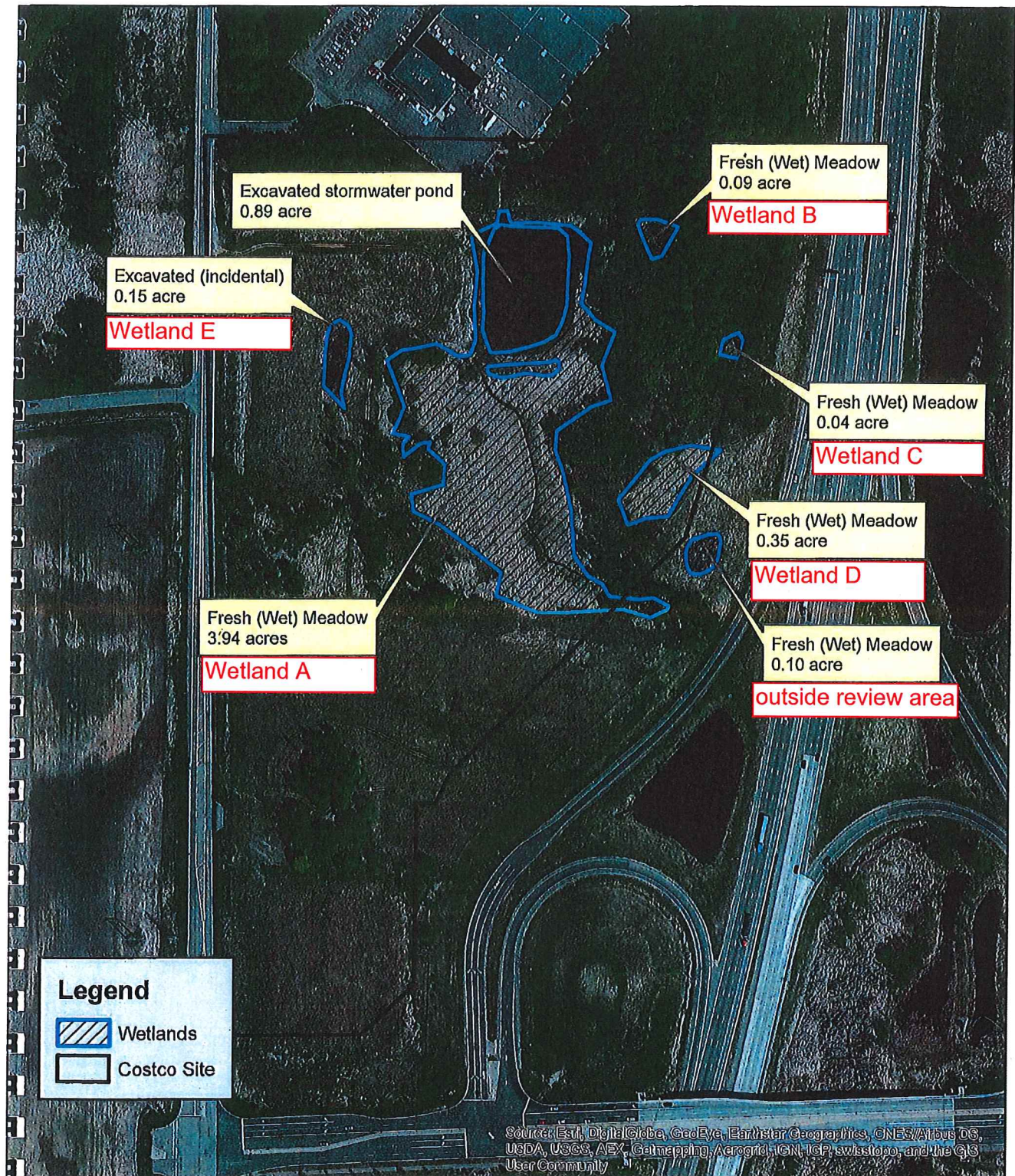
