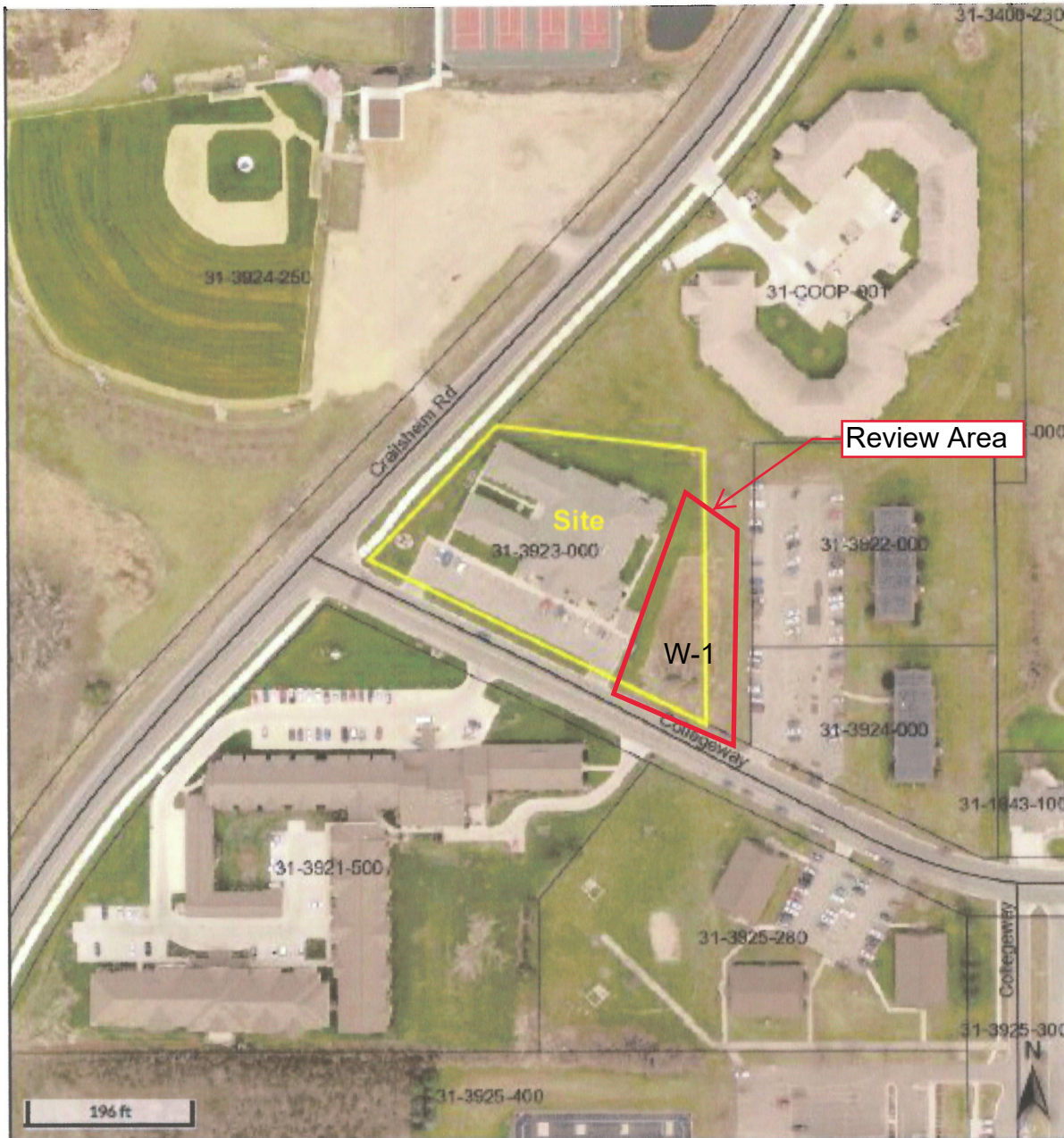

D. ADDITIONAL COMMENTS TO SUPPORT JD: This jurisdictional determination is applicable for Wetland W-1 (0.29 acre), as shown on the enclosed drawings labeled MVP-2019-01695-KJH Page 1 of 4 through Page 4 of 4. W-1 consists of an irregularly shaped depression that was constructed in upland as a result of the construction of the Golden Horizons site in 2004. Prior to the construction of the Golden Horizons assisted living facility the site of W-1 does not include wet signatures. In a 1954 aerial photo, the site of W-1 is in agricultural row crop production and does not include wetland signatures or visible structures. Considering no wetland is apparent prior to the construction activity on the site, which is supported by aerial photo documentation, it is determined that W-1 is not a water of the U.S., because it was created in dry land as a result of construction activity.

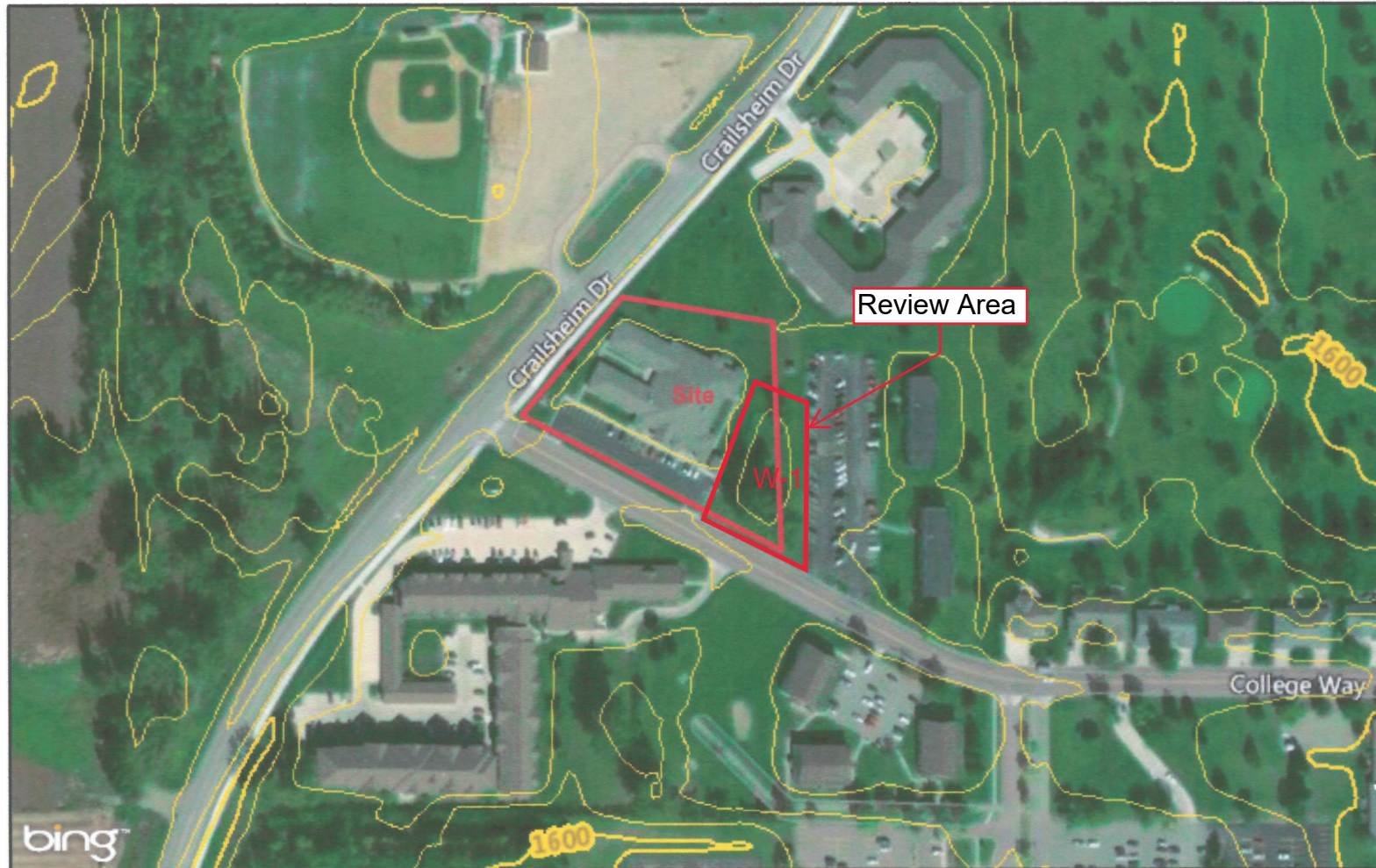

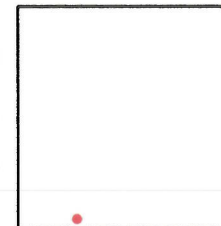

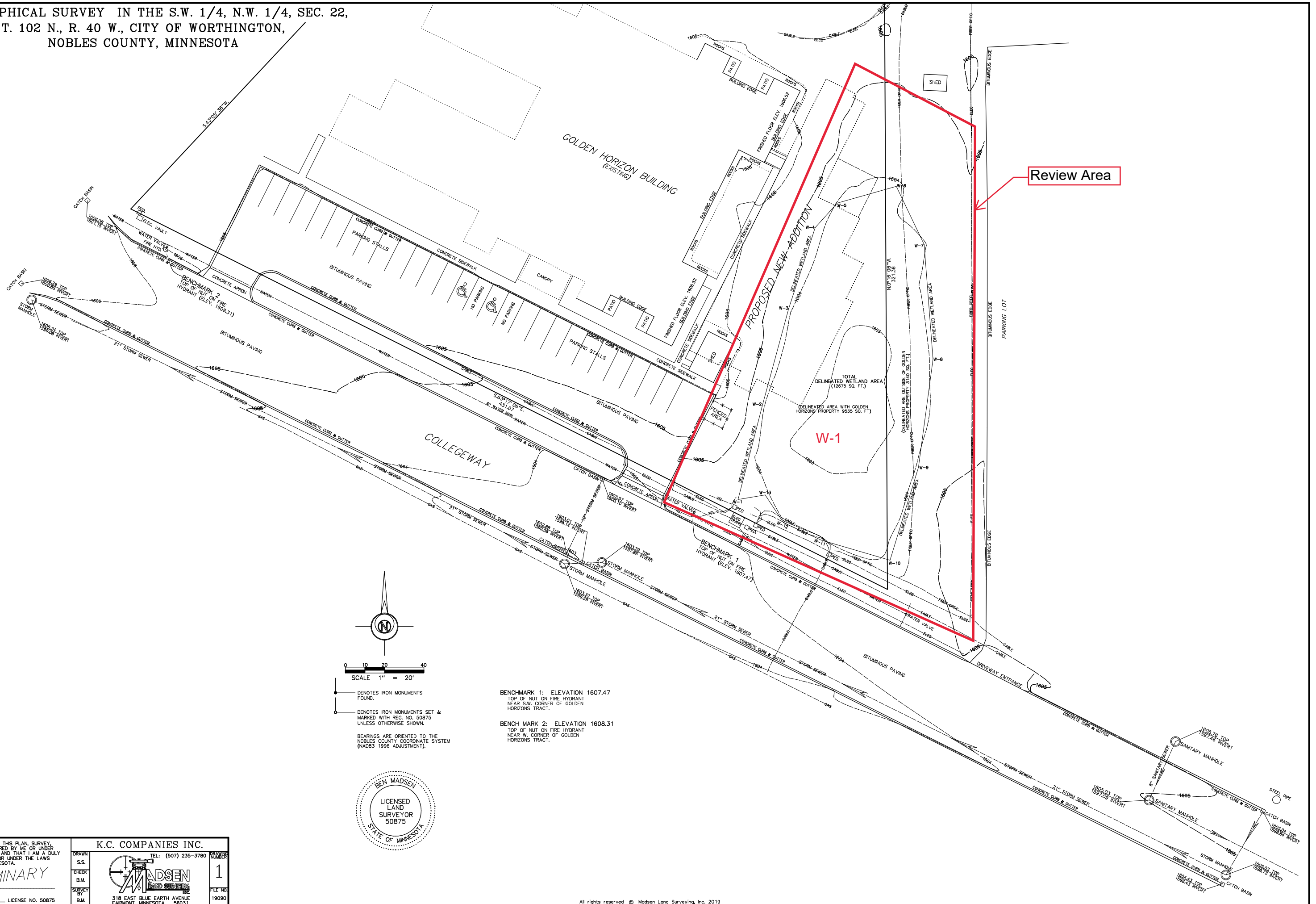
