Both ponds were constructed in upland. SP1 was not located in aerial imagery from 1951 (MN DNR Landview) and in my professional opinion it was constructed in upland sometime after that. SP3 was constructed sometime around 2007-2008 according to Google Earth historical imagery.

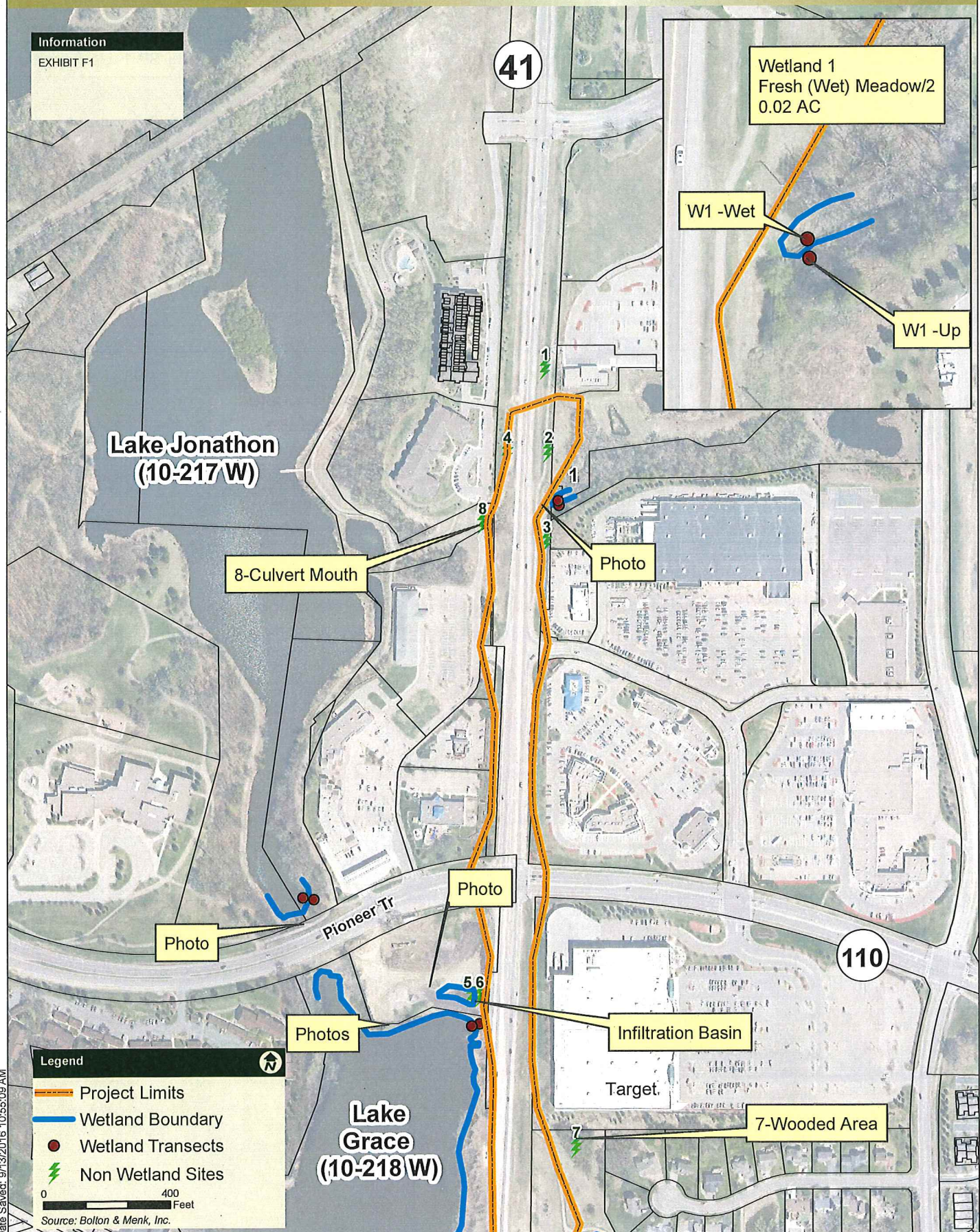
