- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area for this determination is limited to the boundaries of one roadside ditch labeled as Wetland Ditch #1 on the attached figures labeled MVP-2020-00254-BGO MnDOT SP 3116-149/TH 169 & TH 65 AJD Attachments, Pages 1-3 of 3. The ditch is approximately 0.30 acre in size.**

The roadside ditch was constructed in uplands, drains only uplands, and does not carry a relatively permanent flow of water into waters of the U.S. (WOUS). This was confirmed by reviewing aerial photography, national hydrography data, and information provided in the January 2020 Pre-Construction Notification. Per the Rapanos decision, the evaluated ditch is not a WOUS because it is not a tributary and does not have a significant nexus to traditionally navigable waters.
