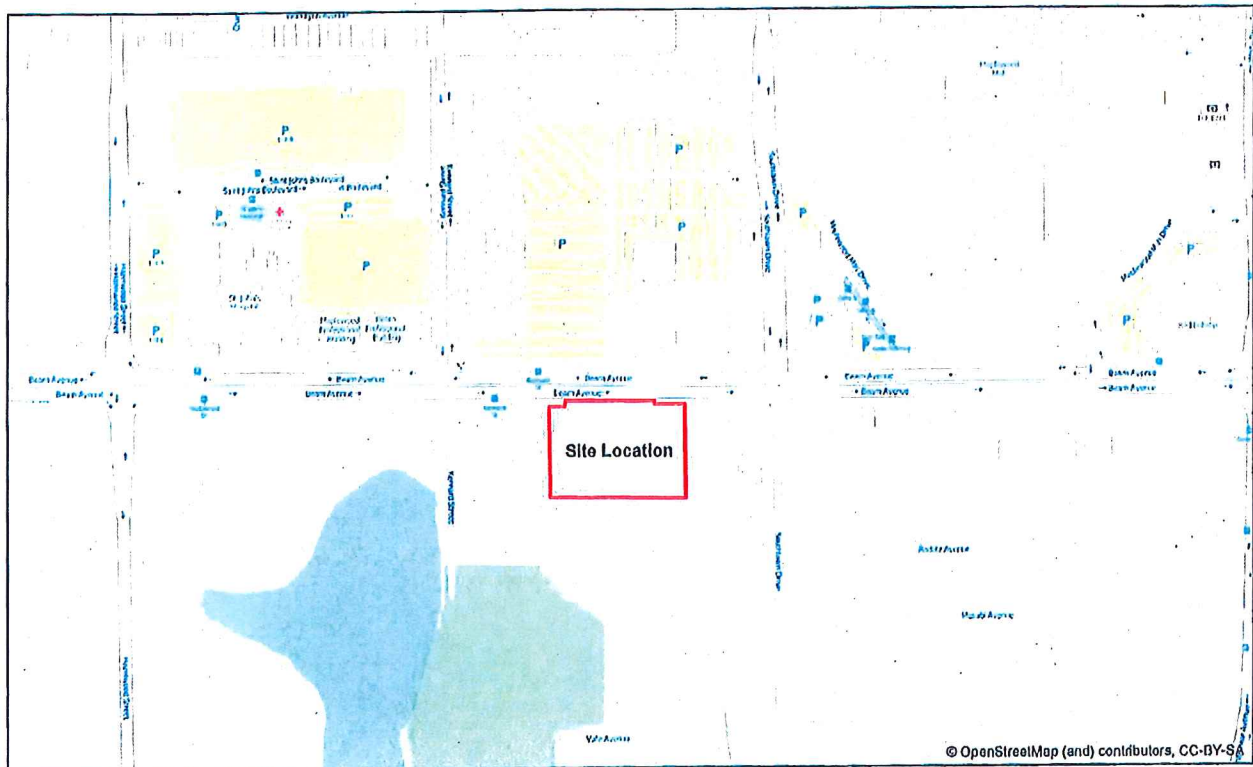
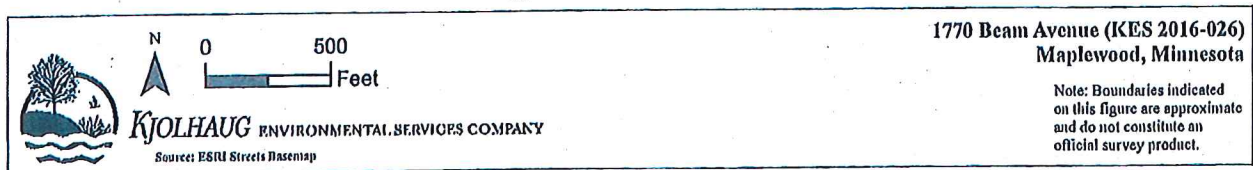


Figure 1 - Site Location



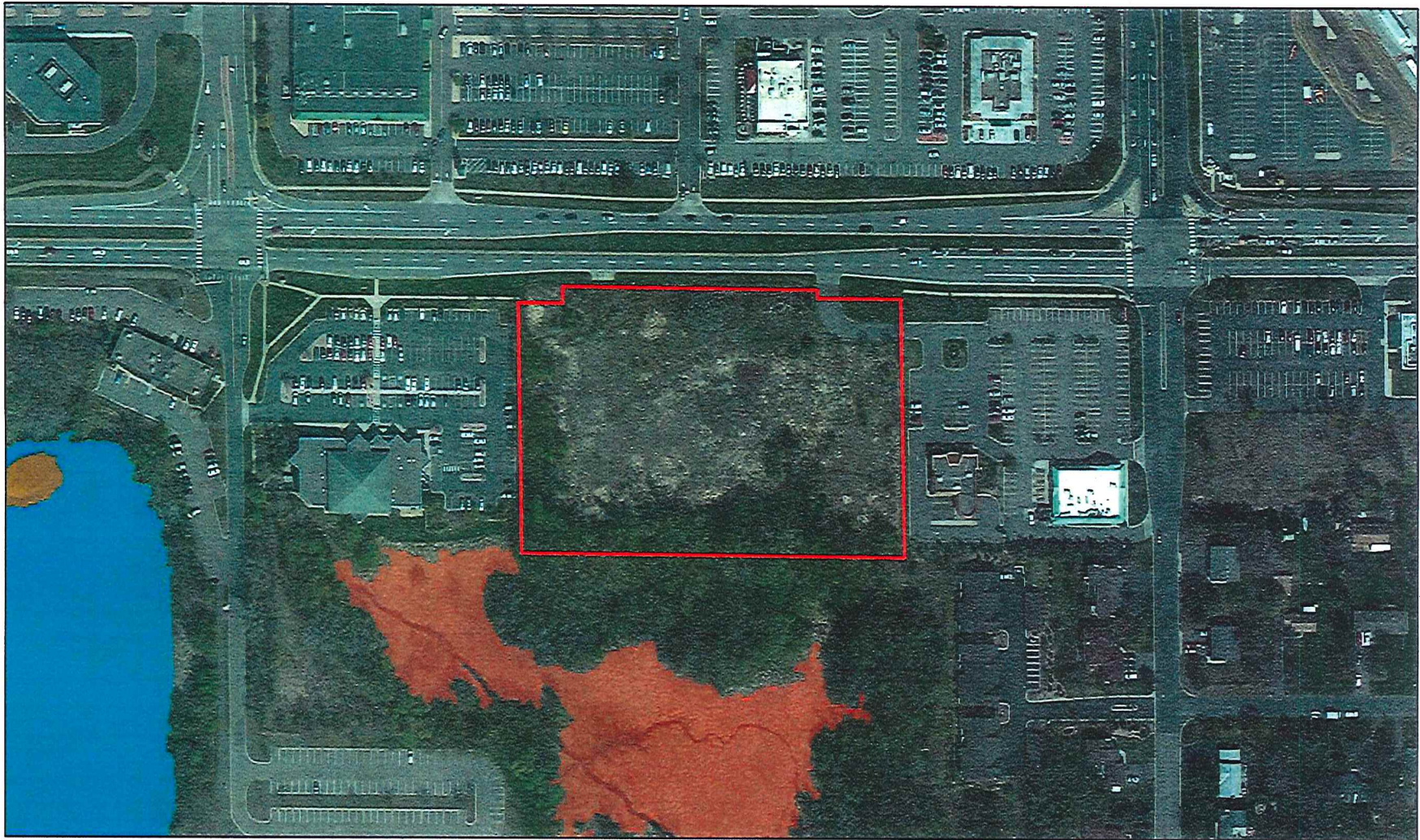


Figure 3 - National Wetlands Inventory
