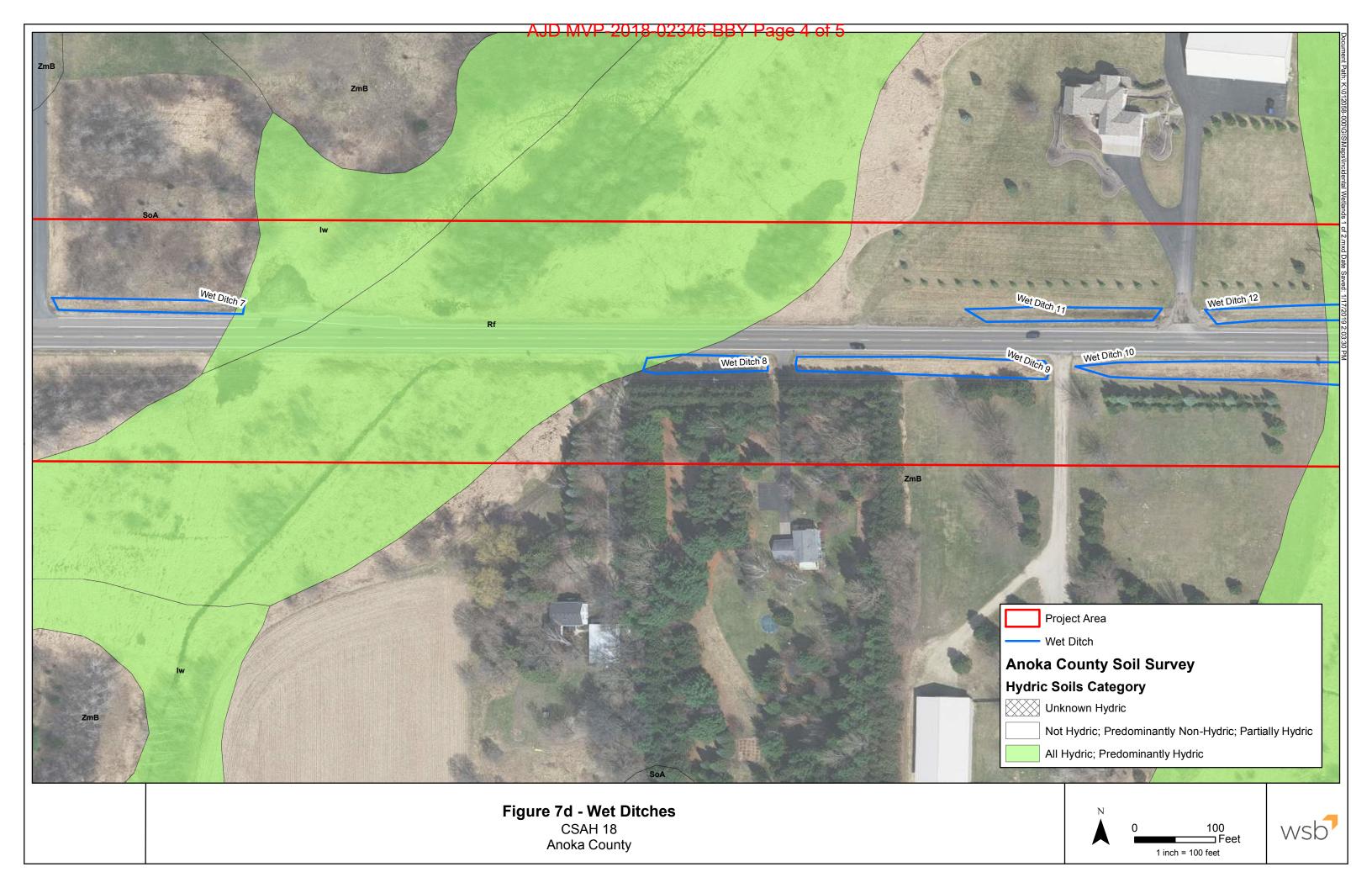
D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area for this determination contains ten roadside ditches labeled Wet Ditch 1, Wet Ditch 2, Wet Ditch 3, Wet Ditch 4, Wet Ditch 5, Wet Ditch 7, Wet Ditch 8, Wet Ditch 9, Wet Ditch 10, and Wet Ditch 11 on the attached figures labeled AJD MVP-2018-02346-BBY Page 1 of 5 through Page 5 of 5. The total size of non-jurisdictional ditches is approximately 1.03 acres. The ditches are constructed features that are not relocated tributaries, are not excavated in a tributary, and do not convey perennial or intermittent flow. This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation report dated July 18, 2018, and the revised figures and data sheets received September 11, 2018 and January 4, 2019. Based on this review, the evaluated ditches are not jurisdictional under the 2015 Clean Water Rule because they meet the terms of paragraph (b)(3)(i).

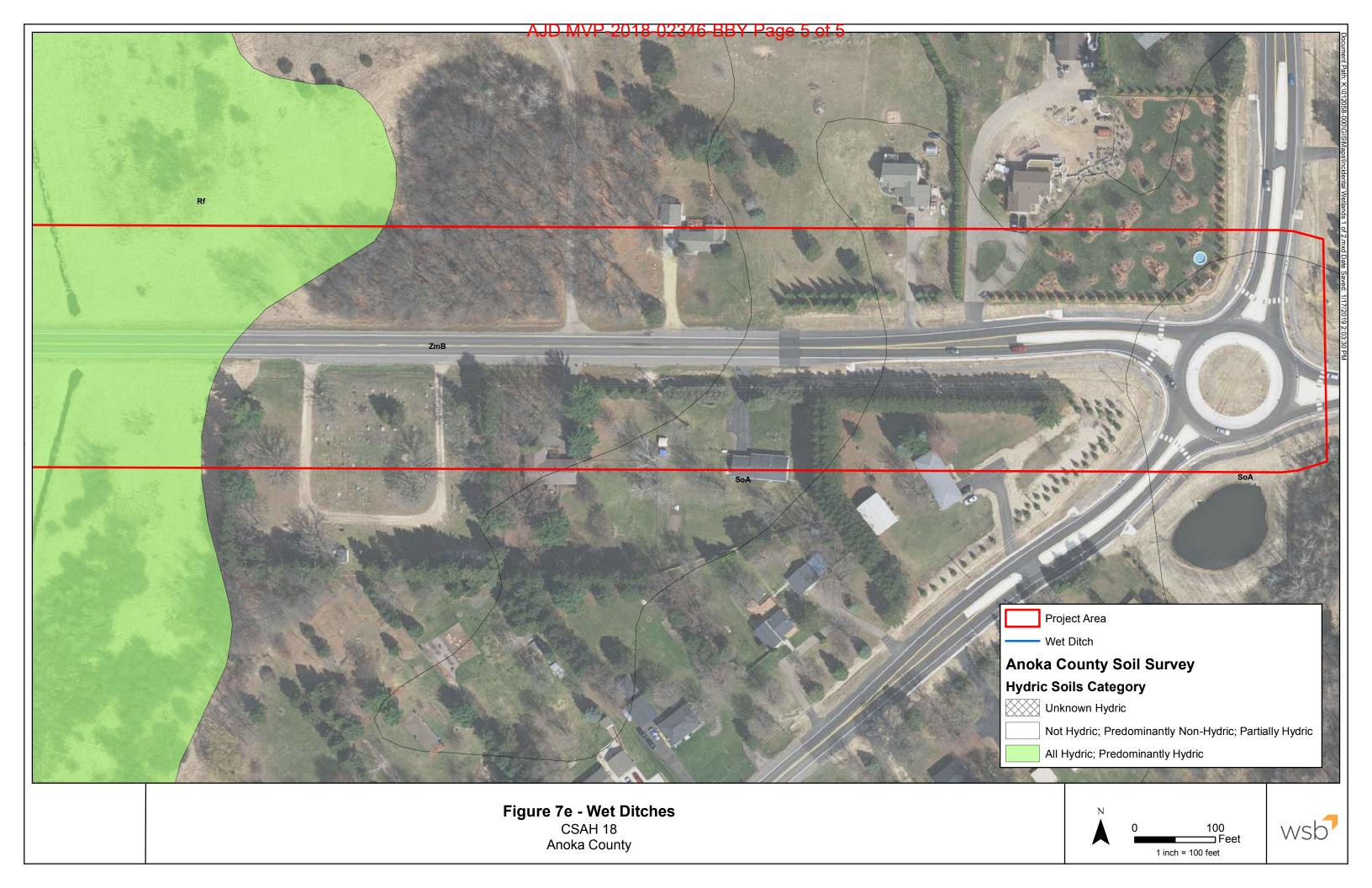
