C. Additional comments to support AJD: Wetland A does not abut at least one point or side of, a paragraph (a)(1)-(3) water. Wetland A would not be flooded by an (a)(1)-(3) water in a typical year. It is not physically separated solely from a paragraph (a)(1)-(3) water by a natural berm, bank, dune, or similar natural feature. It is not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. Contours indicate Wetland A only outlets through an erosional feature, located on the southwestern side of the wetland. The erosional feature directs flow from Wetland A to downstream waters. This erosional feature does not have intermittent or ephemeral flow and is not considered a

(a)(1)(3) water. The erosional feature would not be a tributary and would not be jurisdictional under NWPR. Therefore, Wetland A is an excluded water as a non-adjacent water and is not jurisdictional under the Navigation Waters Protection Rule of the Clean Water Act.
