Wetland 6	0.0732	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 6 is a depressional basin with no outlets. Precipitation flows from the surrounding slope into the basin where it pools and slowly filters into the water table; there is no outflow unless after a heavy rain event when surface flow will overtop the southern wetland edge, flow over uplands, and into the wetland to the south. The wetland to the south does not contribute a surface water connection directly or indirectly to an (a)(1) water.
Wetland 7	0.2833	acre(s)	(b)(1) Non- adjacent wetland.	Wetland 7 is also a depressional basin with no outlets. This wetland is located on a flat topography area on a gradual slope, but does not have an outflow down the slope. Precipitation flows from the surrounding slope into the basin where it pools and filters into the water table because it cannot flow out.
Wetland 8	0.0175	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 8 is a small depressional basin with no outlets. Precipitation flows from the surrounding slope into the basin where it pools and slowly filters into the water table; there is no outflow.
