Wetland 2	1.86	acres	(b)(1) Non-adjacent wetland.	Wetland 2 was determined to be a depressional, isolated, open water/fresh wet meadow wetland. The southern end of Wetland 2 is located approximately 0.55 mile from the Mississippi River; however, it is not located within the floodplain and no hydraulic connection or natural paths or barriers to any (a)(1) – (a)(3) jurisdictional waters could be found.
Wetland 3	0.14	acre	(b)(1) Non-adjacent wetland.	Wetland 3 was determined to be an isolated, forested wetland with no hydraulic connection to any (a)(1) – (a)(3) jurisdictional waters.
Wetland 4	0.20	acre	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	Wetland 4 is a linear wet feature and was determined to be a roadside ditch for drainage and runoff with no culverts providing hydraulic connection and no natural paths or barriers to any (a)(1) – (a)(3) jurisdictional waters.
