C. Additional comments to support AJD: Wetland 1 and Wetland 2 are both completely within a roadside ditch, are more appropriately termed ditch, and will be referred to as ditch hereafter. The ditches are constructed channels to convey water along the transportation corridor. The ditches are not a territorial sea, are not a traditional navigable water, and do not have perennial or intermittent surface water flow. The ditches are not a relocated tributary and were not constructed in an adjacent wetland. Based on the sources provided in this form, there is no evidence that these ditch wetlands were historically a tributary or wetland prior to the construction of the ditch. These features are not jurisdictional for the Corps under Navigable Water Protection Rule of the Clean Water Rule.
