

D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area includes a grassed swale that appears in an agricultural field. As observed in aerial photos taken in 2003, 2004, 2006, 2008, 2009, 2010, 2011, 2013, 2015, and 2016, the grassed swale is present and farming activity was continued up to the edge of the feature with little to no interruption. The grassed waterway is apparent in a May 21, 2008 photo, however, erosion adjacent to the grassed swale appear to show farming activity was not conducted immediately adjacent to the feature. No grassed swale is apparent in 1992. Farming appears to have been conducted through the area of the grassed waterway and no wet signatures are present. No surface water is observed in any of the aerial photos. USGS and NHD data do not identify any surface water features along the grassed waterway location. No wetlands are identified in the review area. A site photo taken on June 10, 2019, of the review area, confirms the presence of a grassed waterway in the agricultural field. Aerial photography confirms that no wet signatures are present.

¹ In many cases these excluded features will not be specifically identified on the approved JD form, unless specifically requested. Corps Districts may, in case-by-case instances, choose to identify some or all of these features within the review area.







