



agricultural field. As observed in aerial photos taken in 1991, 2003, 2004, 2006, 2009, 2010, 2011, 2013, 2015, and

D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area includes an erosional feature that appears in an agricultural field. As observed in aerial photos taken in 1991, 2003, 2004, 2006, 2009, 2010, 2011, 2013, 2015, and 2016, the erosional feature is present and farming activity was continued across the feature with little to no interuption. An erosional feature is apparent in a May 21, 2008 photo, however, U shaped equipment tracks in the adjacent field appear to show the feature was not crossed during field preparation or planting. No erosion feature is apparent in 2011. No surface water is observed in any of the aerial photos. USGS and NHD data identifies an intermittent waterway along the erosional feature. The NWI identified an intermitent waterway with a sand bottom. No wetlands are identified in the review area. A site photo taken on June 10, 2019, of the review area, confirms the presence of an erosional feature in the agricultural field. The erosional feature does not have a defined bed and bank. The feature is most evident by the absence of vegetaion. Aerial photography confirms that no OHWM is present`.


