MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 MVP-2023-00566-JST MFR 1 of 1

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

- 3. REVIEW AREA. The review area is located in Section 36, Township 30 North, Range 22 West, White Bear Lake, Ramsey County, MN. The center coordinates for the site are Latitude: 45.036168, Longitude: -92.986975. The review area is limited solely to Wetland A and Wetland B as identified in the wetland delineation report. The review area is located along County Road D East, north of Interstate 694, west of Century Ave N, and east of McKnight Road N. The nearest waterbody is Silver Lake which is approximately 0.4 miles south of the review area.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not "waters of the United States" even where they otherwise meet the terms of paragraphs (a)(2) through (5). Include the type of excluded aquatic resource or feature, the size of the aquatic resource or feature within the review area and describe how it was determined to meet one of the exclusions listed in 33 CFR 328.3(b).⁷ The aquatic resource identified as Wetland A within the review area consists of two linear road ditches along County Road D East. Based on the wetland delineation report submitted on

behalf of the requestor, the subject wetland was excavated in dry land incidental to the development of County Road D. East to the north of the site and the construction of I-694 and subsequent relocation of County Road D, East to its current location. This led to an increase of runoff from the impervious surfaces which created temporarily flooded conditions within the ditches. These ditches were dud in uplands, drain only uplands, and do not support relatively permanent water. This is supported by historic imagery provided in the delineation report dating back to 1940 to present day which indicates the land use being predominantly agricultural prior to the development of the surrounding area. After the development of the site including the construction of County Road D. East and I-694 to the south, these wetlands were formed in roadside ditches and are mapped within non-hydric soils as indicated in the NRCS Web Soil Survey dataset. This supports the rationale that these wetlands were formed incidental to the development of the area and were formed in uplands. The National Wetlands Inventory reveals no mapped wetlands existing where the subject wetlands exist. This non-jurisdictional determination is in accordance with the Revised Definition of 'Waters of the United States'; Conforming which states that the Corps generally does not consider the following waters to be Waters of the United States; "Ditches (including roadside ditches) excavated wholly in and draining only dry land and that do not carry a relatively permanent flow of water.". including any wetlands that have developed within the boundaries of the excluded feature. Based on this review, Wetland A is not within the boundary of an excluded feature and is not jurisdictional under Section 404 of the Clean Water Act.

b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water). The aquatic resource identified as Wetland B within the review area is not a TNW, territorial sea, or interstate water and is therefore not an (a)(1) water. This determination is supported by the national wetland and hydrography datasets which do not identify any aquatic resources or other potential connections between these aquatic resources and any other waters. Wetland B is located along the east side of the site which developed after the demolition of a house and grading which created a small depression and wetland characteristics. This is supported by aerial imagery obtained from Beacon Schneider Corps spanning from 2014 to 2022 which shows the site prior to the demolition of the house and the wetland forming in the same location after the house was demolished in the last few years. As shown in the aerials, the aquatic resource is surrounded by uplands and impervious surfaces with no swales, erosional features, streams, or

ditches connecting it to any stream or river downstream. Wetland B does not physically abut a relatively permanent (a)(2) impoundment or (a)(3) tributary and is not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform. Wetland B within the review area does not have a continuous surface connection to a relatively permanent jurisdictional water and as such does not meet the definition of adjacent and cannot be evaluated as an (a)(4) wetland; therefore, this aquatic resource is not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming' 88 FR 61964 Final Rule.

Because the Supreme Court in Sackett adopted the Rapanos plurality standard and the 2023 rule preamble discussed the Rapanos plurality standard, the implementation guidance and tools in the 2023 rule preamble that address the regulatory text that was not amended by the conforming rule, including the preamble relevant to the Rapanos plurality standard incorporated in paragraphs (a)(3), (4), and (5) of the 2023 rule, as amended, generally remain relevant to implementing the 2023 rule, as amended.






Figure 1. Location Map






Figure 3. Aerial Photo with Approximate Wetland Boundary
