MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 MVP-2025-00940 MFR 1 of 12

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

¹ While the Revised Definition of "Waters of the United States"; Conforming had no effect on some categories of waters covered under the CWA, and no effect on any waters covered under RHA, all categories are included in this Memorandum for Record for efficiency.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Wetland IDs Wet Ditch 1 (0.01 acre), Wet Ditch 2 (0.01 acre), Wet Ditch 3 (0.14 acre), Wet Ditch 4 (0.19 acre), Wet Ditch 5 (0.18 acre), Wet Ditch 6 (0.7 acre), Wet Ditch 7 (0.03 acre), Wet Ditch 8 (0.03 acre), Wet Ditch 9 (0.08 acre), and Wet Ditch 10 (0.04 acre) are linear roadside drainage ditches constructed in upland and draining only upland based on the following:

- US Geological Service 3DEP DEM and MNDNR 2-foot contour maps shows the ditches are located in areas of the project that are higher in elevation and supportive of uplands.
- NHD data revealed none of the ditches are relocated or captured tributaries.
- Recent aerial photos do not show relatively permanent flow in the aforementioned aquatic resources.

Based on the desktop resources reviewed, these aquatic resources are linear roadside drainage ditches constructed in upland, draining only upland, and do not carry a relatively permanent flow of water. Therefore, these aquatic resources have been determined to be Paragraph (b)(3) excluded ditches and not subject to Section 404 of the Clean Water Act (CWA).

b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).


Wetland IDs, Wetland 6-3 (0.17 acre), Wetland 7-1 (0.18 acre), and Wetland 7-3 (0.05 acre) are not traditionally navigable waters (TNW), territorial seas, or interstate waters and therefore are not (a)(1) waters. Topographic maps, LiDAR data, and recent aerial imagery indicate these wetlands are depressional basins surrounded entirely by upland. Wetland IDs, Wetland 6-3, Wetland 7-1 and Wetland 7-3 do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. These wetlands are located approximately 0.5 mile from the nearest requisite jurisdictional water, the South Fork Roseau River, located in the northern and central portion of the review area. Wetland IDs, Wetland 6-3, Wetland 7-1 and Wetland 7-3 are non-tidal wetlands that do not abut a relatively permanent jurisdictional water and, as such, do not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, these wetlands are not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming" 88 FR 61964 Final Rule.














