#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), MVP-2025-01042-KMM. MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>4</sup> the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

## 8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not "waters of the United States" even where they otherwise meet the terms of paragraphs (a)(2) through (5). Wetland IDs WD1 (0.15 acre), WL2 (0.26 acre), WD5 (0.17 acre), and WD6 (0.06 acre) associated with the Trunk Highway 15 review area and Wetland IDs WL4 (0.30 acre) and WD6 (0.12 acre) associated with the Trunk Highway 111 review area are linear roadside drainage ditches and drain only uplands based on a review of the US Geological Service 3DEP DEM and Hillshade maps; 2016 MNDNR Hillshade map and the NWI map. Recent aerial photos do not show relatively permanent flow in the aforementioned aquatic resources. Based on the desktop resources reviewed these aquatic resources are linear roadside drainage ditches constructed in uplands, draining only uplands, and do not carry a relatively permanent flow of water. Therefore, these aquatic resources have been determined to be Paragraph (b)(3) excluded ditches and are not subject to Section 404 of the Clean Water Act (CWA)

b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland IDs WL1 (1.58 acres), WL2 (0.02 acre), and WL5 (0.19 acre) associated with the Trunk Highway 111 review area, are not traditionally navigable waters

(TNW), territorial seas, or interstate waters and are therefore not an (a)(1) water. The nearest relatively permanent waterway (RPW) to the review area (Swan Lake) is approximately 0.83 miles southeast.

The National Wetland Inventory (NWI) does not map any of the delineated wetlands within the project area. Desktop resources like 3DEP Digital Elevation Model and Minnesota DNR - Hillshade support the NWI along with Lidar imagery showing that the identified wetland areas lack continuous surface connections to a water of the United States.

The areas labeled WL1, WL2, and WL5 were evaluated as a potential (a)(4) waters but they do not directly abut a relatively permanent jurisdictional water and, as such, do not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, these wetlands are not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming" 88 FR 61964 Final Rule.
