D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area consists only of Area A as outlined in green on the attached figures labeled MVP-2018-03544-AIS Page 1-5 of 5. Soils within the area in question consist of Lester-Kilkenny complex, 16 to 22 percent slopes. According to Natural Resources Conservation Service (NRCS), this soil unit is predominantly non-hydric. A review of available historic aerial photography indicated no obvious wetness signatures within the review area until the mid 1970s. The topographical position in the middle of a slope indicates the pond is more likely to be ornamental than for stormwater control. These facts support this determination that the water within Area A is an ornamental water feature constructed in uplands.
