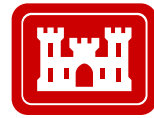

D. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland basins included in this AJD are further than 4,000 feet from a water identified in paragraphs (a)(1)-(a)(5) and are not located within the 100-yr flood plain of a water identified in paragraphs (a)(1)-(a)(3). Ditches do not flow through the wetlands identified in this AJD. The wetlands are not waters of the US due to exceeding the distance threshold.

Wetland 1	Outside distance threshold or 100 yr floodplain	Wetland 1 is not located in a 100 year floodplain of an (a)(1)-(a)(3) water and occurs outside of the 4000 foot threshold of an (a)(1)-(a)(5) water. The closest potential (a)(1)-(a)(5) water to Wetland 1 is Powers Lake, located approximately 6,300 feet to the southwest of Wetland 1. This wetland is not a water of the US due to exceeding the distance threshold.
Wetland 2	Outside distance threshold or 100 yr floodplain	Wetland 2 is not located in a 100 year floodplain of an (a)(1)-(a)(3) water and occurs outside of the 4000 foot threshold of an (a)(1)-(a)(5) water. The closest potential (a)(1)-(a)(5) water to Wetland 2 is Powers Lake, located approximately 6,600 feet to the southwest of Wetland 2. This wetland is not a water of the US due to exceeding the distance threshold.
Wetland 3	Outside distance threshold or 100 yr floodplain	Wetland 3 is not located in a 100 year floodplain of an (a)(1)-(a)(3) water and occurs outside of the 4000 foot threshold of an (a)(1)-(a)(5) water. The closest potential (a)(1)-(a)(5) water to Wetland 3 is Powers Lake, located approximately 6,800 feet to the southwest of Wetland 3. This wetland is not a water of the US due to exceeding the distance threshold.
