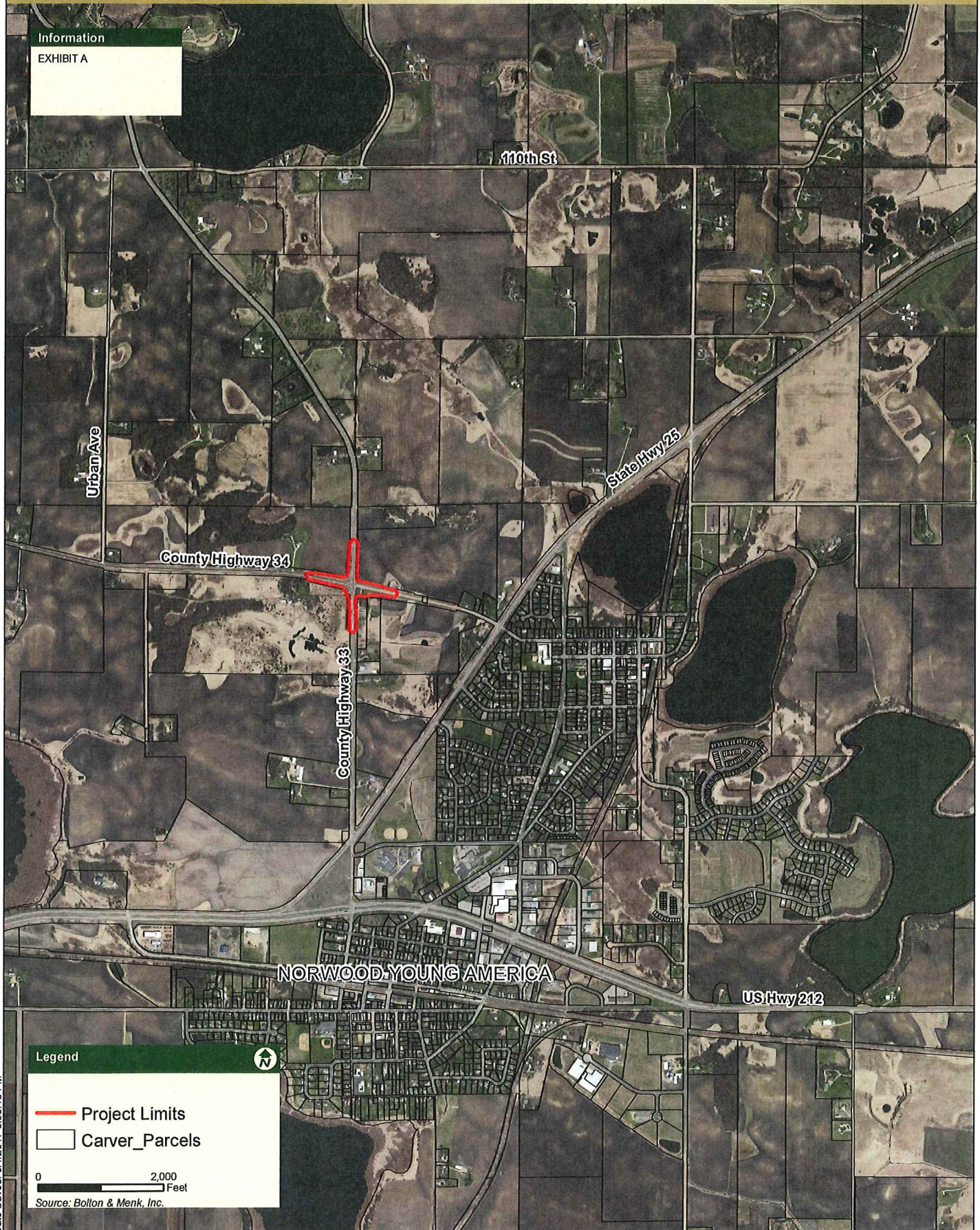

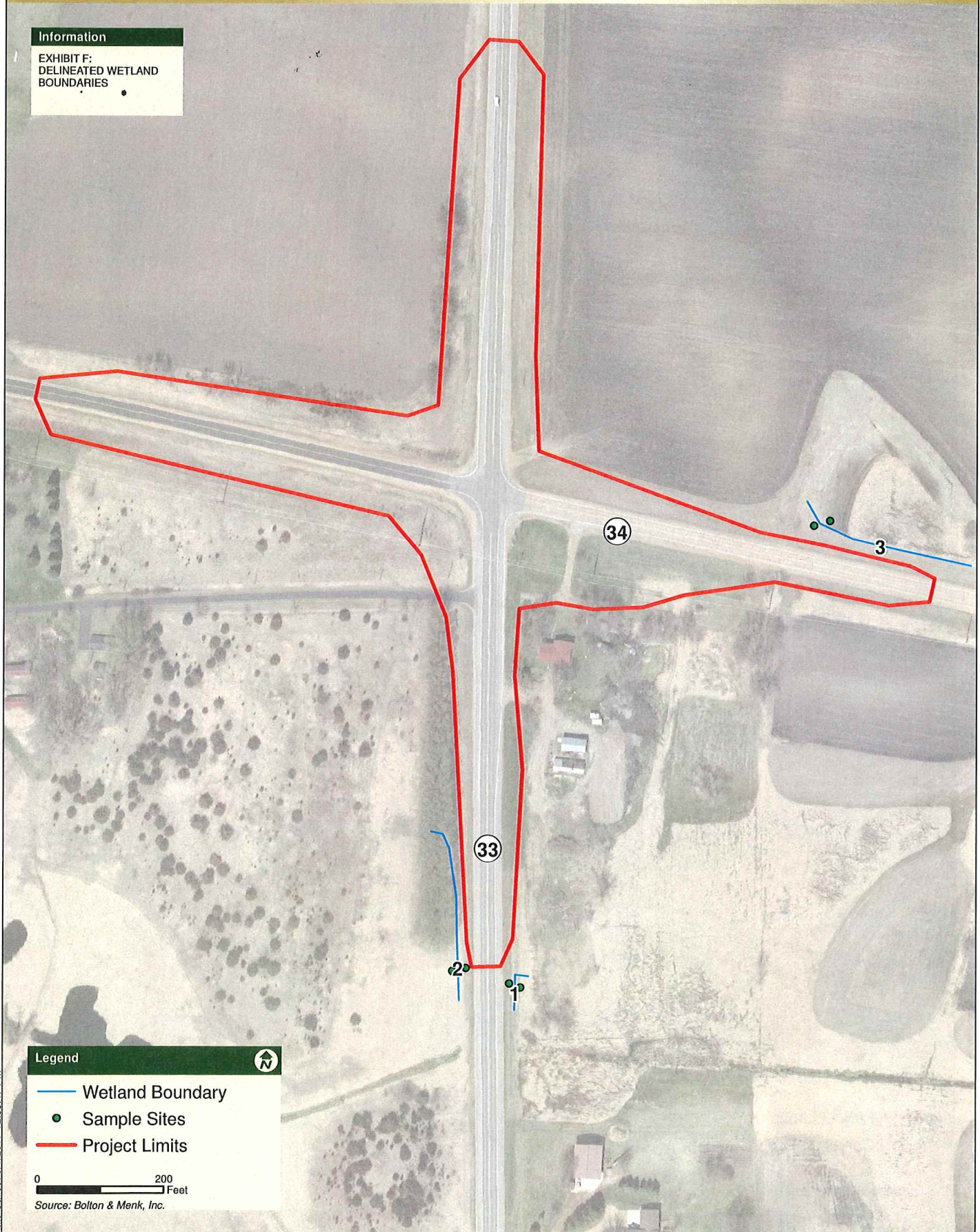
PROJECT SOIL SURVEY
