Wetland A in the review area is not adjacent to a (a)(1), (a)(2), or (a)(3) waterway, is not inundated by flooding of a (a)(1), (a)(2), or (a)(3) waterway, and does not connect to an (a)(1) water through an (a)(2) or (a)(3) waterway. Therefore, wetland is not an (a)(4) water.
