Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is an approximately 1-acre recreational pond within the red boundaries on the enclosed figures labeled MVP-02655-TJH Page 1 of 2 through 2 of 2, located south of Deerfield Road. The pond was created in 1994 through the construction of an earthen dam across a low spot in a field on the property. The area is not indicated on the National Wetland Inventory. A review of aerial photos prior to 1994 show the location of the pond to be upland field. Photos from 1994 provided by the applicant show the pond in use for recreational swimming. The review has led to the determination that the pond is a recreational pond created in upland. The non-jurisdictional determination for this basin was completed in accordance with the preamble to the 1986 Corps Regulations (33 CFR Part 328.3 - Definitions), which states that the Corps generally does not consider certain waterbodies to be waters of the US, including: Artificial, constructed lakes and ponds created in dry land such as farm and stock watering ponds, irrigation ponds, settling basins, fields flooded for rice growing, log cleaning ponds, or cooling ponds; artificial reflecting pools or swimming pools created in dry land; and small ornamental waters created in dry land. Therefore, the pond was determined to not be jurisdictional under the Clean Water Act.
