Explain: **The review area contains two wetlands, labeled W-1 and W-2 on the attached figure MVP-2019-00711-AIS Page 4 of 4. These wetlands are not bordering, contiguous with, or neighboring another WOUS nor are these aquatic resources separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 950 feet to the west of the nearest wetland (W-2). Street-level imagery confirms no surface connection to nearby tributaries.**

**The wetlands located within the review area do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Furthermore, these wetlands are hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and do not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W-1 and W-2 are not regulated by the Corps under Section 404 of the Clean Water Act.**
