Explain: One stormwater detention basin was reviewed within the approximate 140-acre project area. The stormwater detention basin, approximately 1.8-acres, was constructed in dry land around 1990 and is not a water of the U.S. This was confirmed by reviewing aerial photographs dated 1940, 1963, 1970, 1975, 1980, 1985, and 1990, WWI, and the NRCS Soil Survey data. The determination of no jurisdiction for this stormwater detention basin is in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the U.S.; artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing.
