Explain: The review area contains three aquatic resources (Wetland 2: 0.03 acre, Wetland 4: 0.035 acre, and Wetland 5: 0.020 acre) that are ditches constructed in uplands prior to 1984. Review of site photos indicate these ditches do not convey a relatively premanent flow. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.



## Surface Water Data Viewer Map


