Explain: The review areas contain four aquatic resources (labeled as Wetlands 1, 5, 6, and 8 on Figures) that are isolated depressions with no surface or shallow subsurface connection to any waters of the United States, including an unnamed tributary of the Devils River located approximately 1,700 feet to the southeast. These wetlands do not border, neighbor, nor are contiguous with another water of the U.S. They are not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use consists mostly of agricultural fields, commercial development, and paved two-lane roadways, precluding an ecological connection to a WOUS.

These aquatic resources do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these aquatic features are not regulated by the Corps under Section 404 of the Clean Water Act.

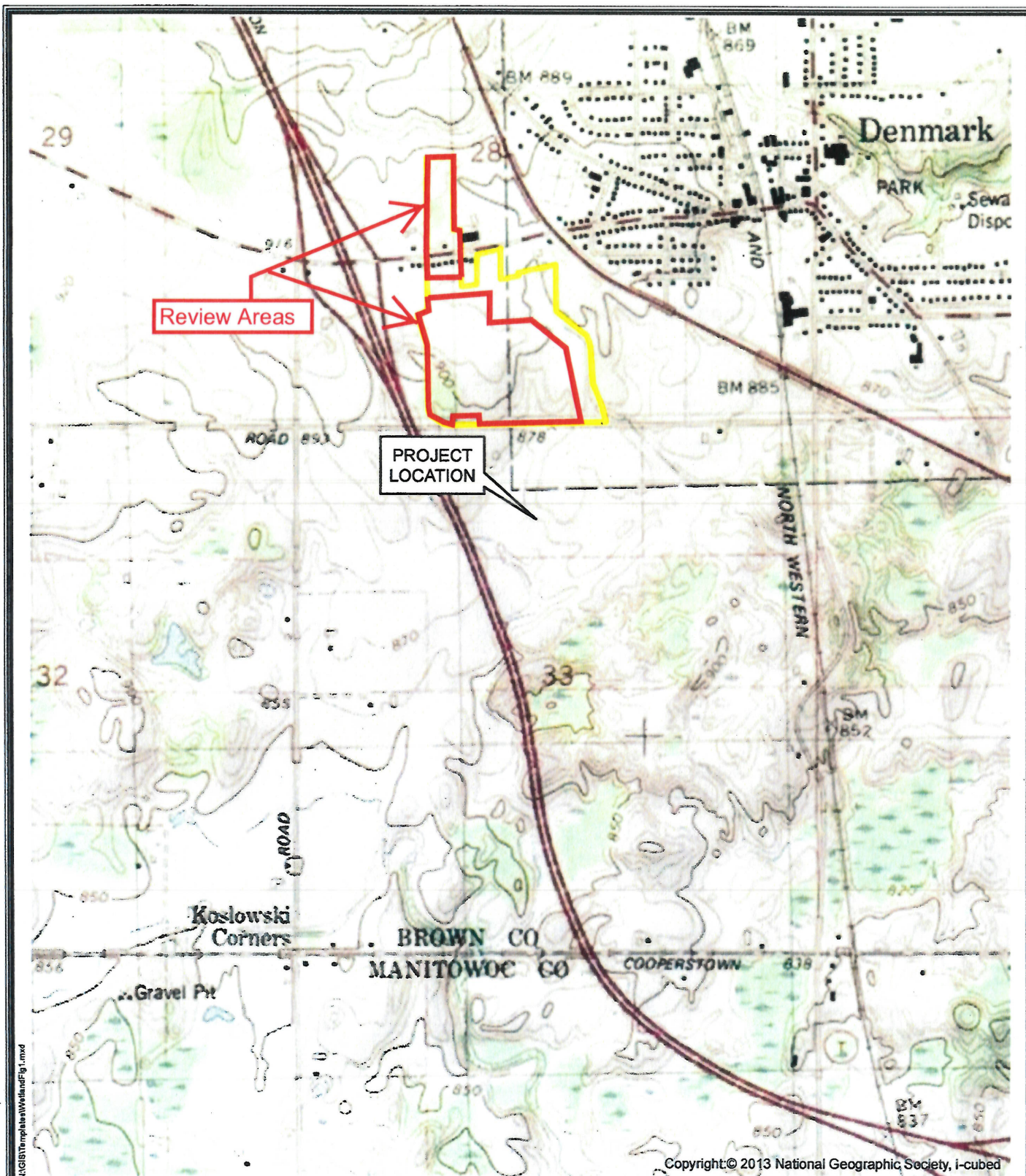

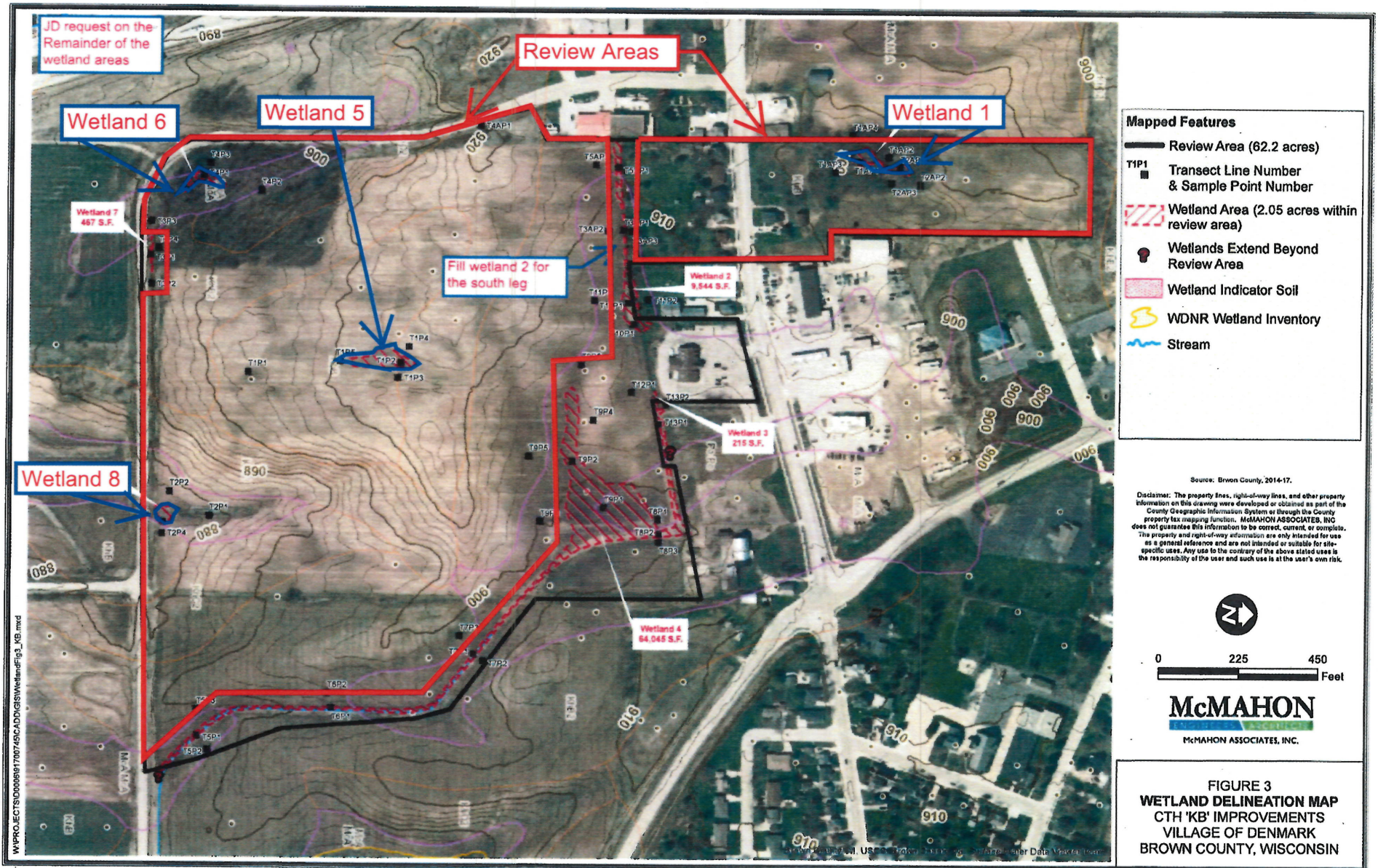
