Explain: The review area contains six aquatic resources (Wetland J: 0.126 acre, Wetland K: 0.054 acre, Wetland L: 0.094 acre, Wetland E: 0.133 acre, Wetland F: 0.051 acre, and Wetland N: 0.001 acre) that are ditches constructed in uplands. Review of site photos indicate these ditches do not convey a relatively permanent flow. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in *Rapanos v. U.S.* and *Carabell v. U.S.* issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.

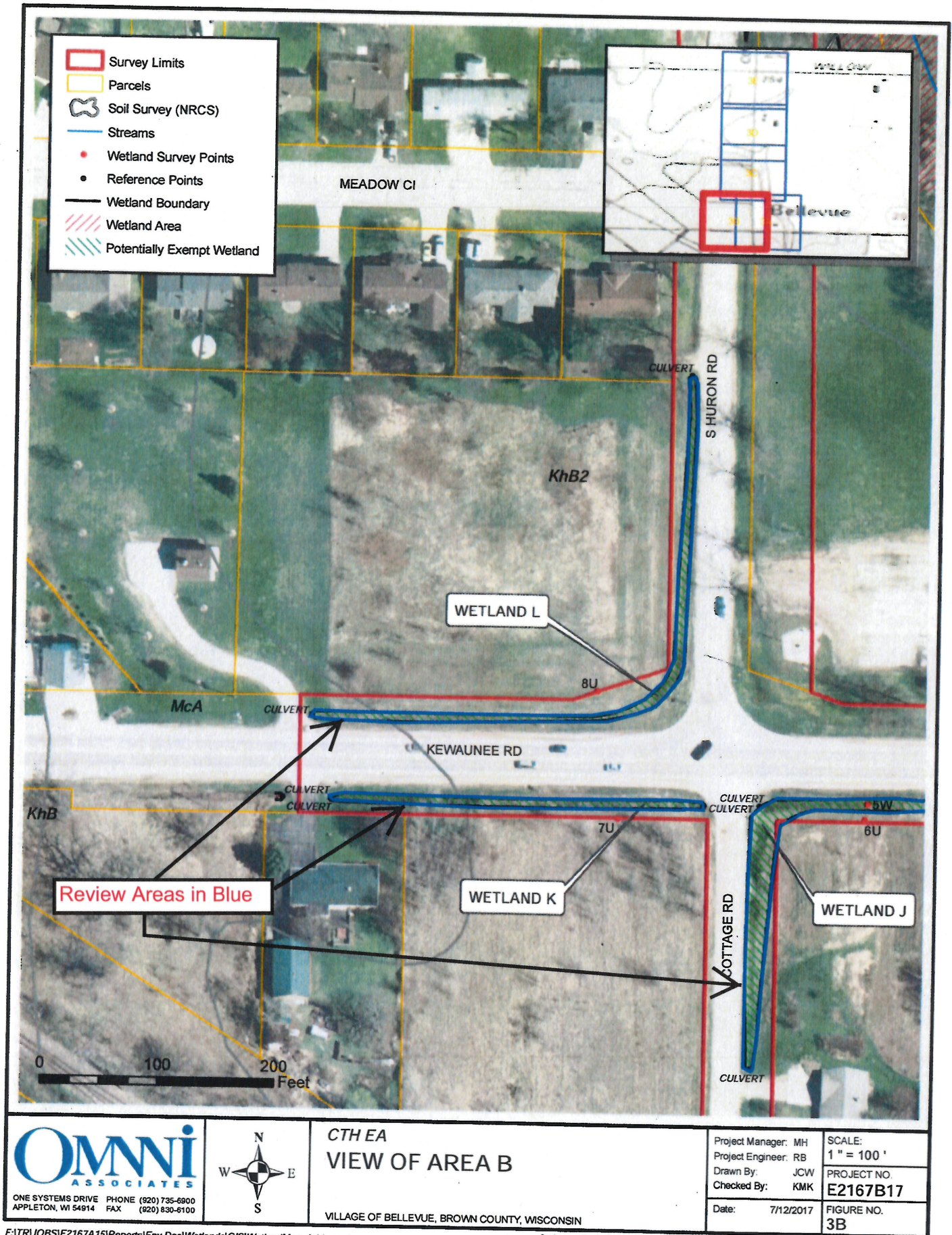

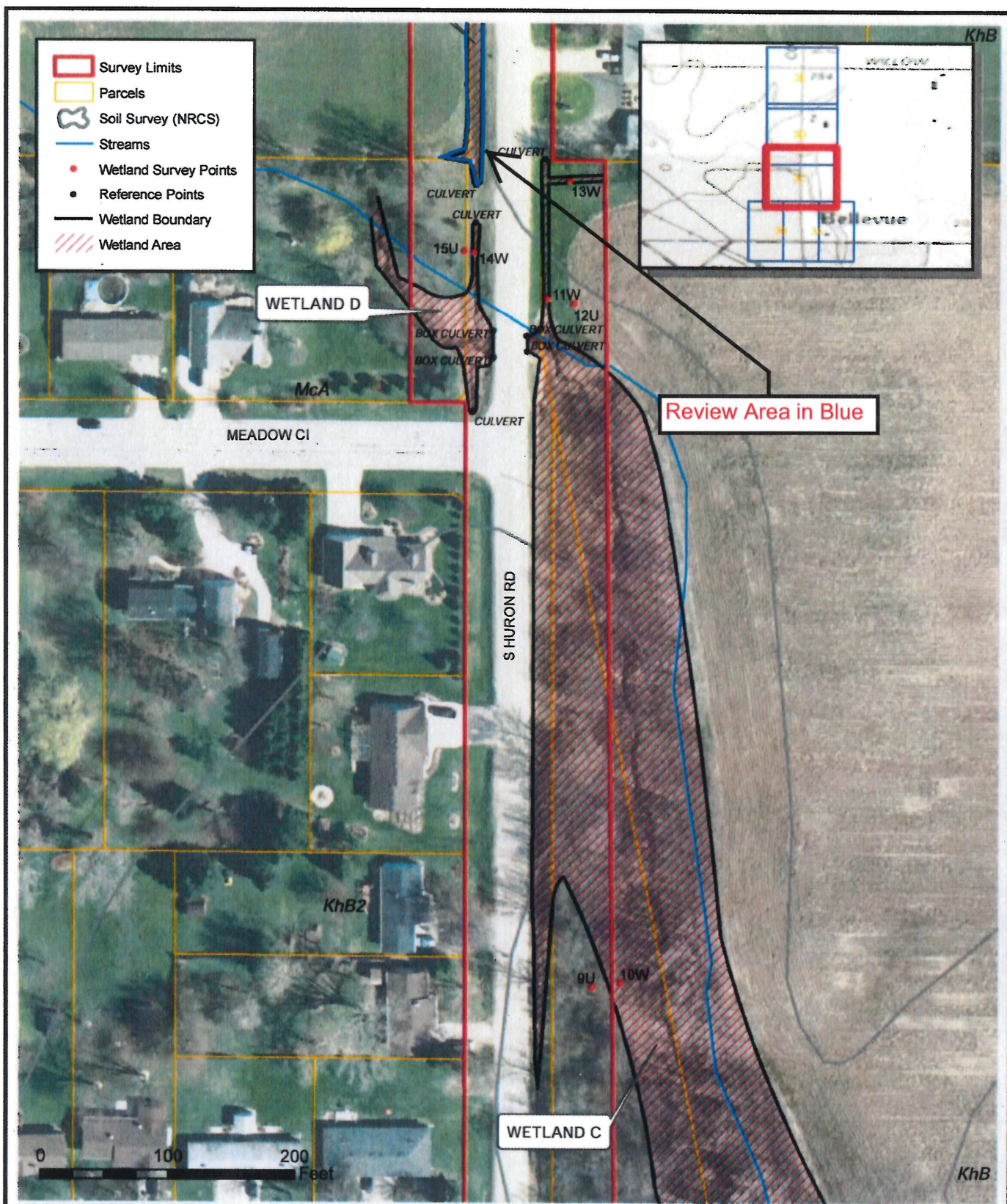

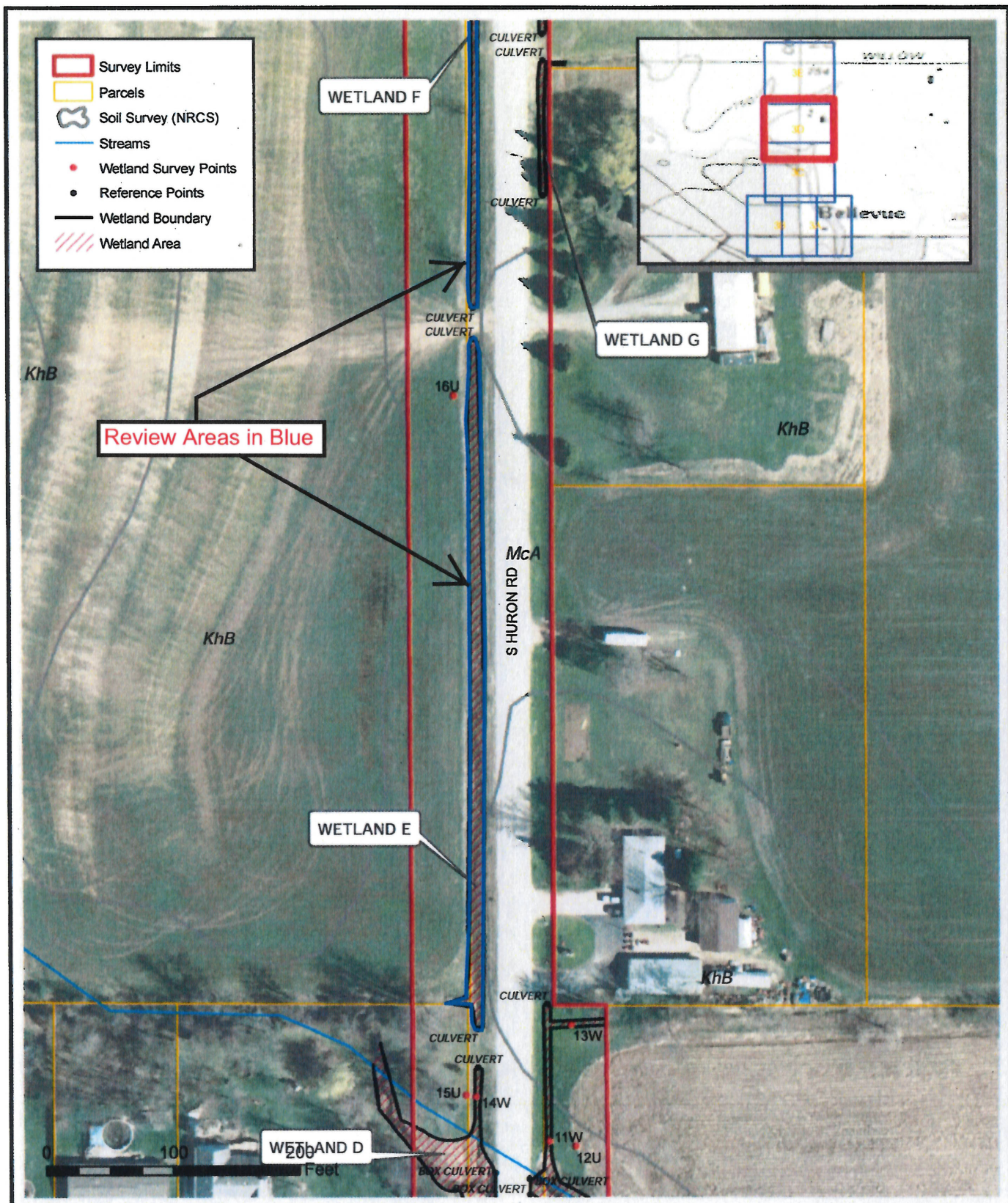
