MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), MVP-2020-00099-JLK [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

Wetlands W-1, W-2, W-4, W-5/Pond 2, and W-6 are not TNWs, territorial seas, or interstate waters and therefore are not (a)(1) waters. Topographic maps, Google Earth Pro aerial imagery, and site photos provided in the delineation report, indicates Wetlands W-1, W-2, W-4, and W-6 are confined within the north/central portion of the review area. Wetlands W-1 and W-2 are surrounded by uplands involving a paved roadway immediately north and forested areas to the west, east, and south while Wetlands W-4 and W-6 are surrounded by uplands involving the same paved roadway to the south and west, and forested areas to the north and east. The delineation report shows Wetland W-5/Pond 5 is a long, linear-shaped wetland extending from the north/central portion of the review area to the southeast corner with uplands involving forested areas to the east and west. Previously mentioned data sources showed the wetland extends into a roadside ditch associated with Indian Springs Drive to the north. While Lidar data also illustrates a roadside ditch extending east and west along the south side of the roadway, a review of Google Earth historical aerial photos and ground level photos demonstrates the ditch is shallow with no standing/flowing water, indicating this ditch does not have a relatively permanent flow. Lidar data also shows Wetland W-5 extends outside of the review area to the southeast. However, further review of Lidar data, topographic maps, and aerial imagery,

indicates the swale-like feature continues southward approximately 500 feet where it then transitions to uplands involving an agricultural field to the west, east, and south.

Based on the above information, Wetlands W-1, W-2, W-4, W-5/Pond 5, and W-6 do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary and are not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform. Therefore, Wetlands W-1, W-2, W-4, W-5/Pond 5, and W-6 are not jurisdictional under the 2023 Revised Definition of "Waters of the United States': Conforming" 88 FR 61964 Final Rule.
