MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the “Revised Definition of ‘Waters of the United States’”; (88 FR 3004 (January 18, 2023) as amended by the “Revised Definition of ‘Waters of the United States’; Conforming” (8 September 2023),¹ MVP-2023-01194 [[MFR 1 of 1](#)]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army (“the agencies”) published the “Revised Definition of ‘Waters of the United States,’” 88 FR 3004 (January 18, 2023) (“2023 Rule”). On September 8, 2023, the agencies published the “Revised Definition of ‘Waters of the United States’; Conforming”, which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) (“*Sackett*”).

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

[Review of a 2023 McMahon Associates wetland delineation report, historical images (Google Earth Pro), GIS mapping and LIDAR resources [hillshade and DEM GIS layers from the Mississippi Valley Division (MVD) Regulatory Viewer] indicate that wetland 1 (W01) is a ruderal wet meadow consisting of two swales joining at the south edge of the review area where it meets a roadside ditch. The roadside ditch drains to the east, through a road culvert into a relatively permanent water (RPW). Historic aerial imagery and LIDAR review of the roadside ditch does not indicate hydrologic conditions exist that would support relatively permanent flows. The roadside ditch and W01 are separated from the RPW by Technology Drive.

In accordance with current WOTUS guidance and the U.S. Supreme Court decision *Sackett v. EPA* (2023), manmade features such as roadside ditches cannot serve as a continuous surface connection between wetlands and relatively permanent waters. Although W01 extends into the ditch, this feature does not create a jurisdictional connection to any RPW. Based on the change of elevation and the boundaries depicted in the wetland delineation report, we have determined W01 transitions into uplands along
