MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ MVP-2024-00183-JLK MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

- a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not “waters of the United States” even where they otherwise meet the terms of paragraphs (a)(2) through (5). Include the type of excluded aquatic resource or feature, the size of the aquatic resource or feature within the review area and describe how it was determined to meet one of the exclusions listed in 33 CFR 328.3(b).⁷

Based on a review of the wetland delineation report and historical aerial photos provided via Google Earth Pro, Ditches 1A, 1B, 1C, 2, 3A, 3B, and 4 meet the definition of a category (b)(3) exclusion for ditches excavated wholly in and draining only dry land and that do not carry a relatively permanent flow of water. All ditches run north to south along the west and east sides of Poplar Road. Review of Lidar data and historical aerial photos shows a slight swale-like feature present that traverses from northeast of the review area to the southwest. However no other wet signatures or other wetland indications (standing water, repeated vegetation stress, etc.) in the locations of the ditches were observed. Additionally, the Wisconsin Surface Water Data Viewer indicates no mapped wetlands or hydric soils present within the footprints of all four ditches. Based on this information, Ditches 1A, 1B, 1C, 2, 3A, 3B, and 4 are not jurisdictional under the 2023 Revised Definition of “Waters of the United States”: confirming 88 FR 61964 Final Rule.



Project Area (+/- 0.79 acres)




Site Location


