MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),¹ MVP-2024-00299-BJL, MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

- 3. REVIEW AREA. The review area is limited to Wetland 4 and Wetland 6 as shown on the attached Figure labeled MVP-2024-00299-BJL AJD Figure 1. The review area is located at 44.26641, -90.32415 in the Town of Bear Bluff, Jackson County, Wisconsin. There are no other JDs associated with the review area.


- a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not "waters of the United States" even where they otherwise meet the terms of paragraphs (a)(2) through (5). - b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Based on review of the delineated wetland boundaries and landscape positions depicted on aerial imagery, Wetlands 4 and 6 are not a TNW, territorial sea, or interstate water; therefore, these waters are not category (a)(1) waters. Based on review of field investigations provided in the March 21, 2024 Wetlands and Waterways, LLC wetland delineation report, Google Earth and historic aerial images, Jackson County GIS, DEM and Hillshade GIS layers (from the Mississippi Valley Division Regulatory Viewer), these wetlands are not a tributary and have not been created by impounding a water of the U.S.; therefore, these wetlands are not a category (a)(2) or (a)(3) water. The review area is located approximately 500 feet southwest of the closest relatively permanent water (Unnamed Lake) that has a surface water connection to Remington Ditch that flows into Yellow River. Wetlands 4 and 6 do not directly abut a jurisdictional water identified in paragraph (a)(1), (a)(2), or (a)(3) of the conforming rule and are not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform. Review of the submitted delineation report and topographic map provided with the jurisdictional request indicate Wetland 4 is wet meadow depression surrounded by upland and Wetland 6 is a forested depression surrounded by upland. Wetlands 4 and 6 are depressional features lacking a continuous surface connection to a relatively permanent jurisdictional water and as such does not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, Wetlands 4 and 6 are not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming" 88 FR 61964 Final Rule.
