MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ [MVP-2024-01168-AJK] [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

The review area includes 3 wetlands, labeled Drainageway 1, Drainage Ditch 1, and Drainage Ditch 2. The two drainage ditches are roadside ditches built to convey localized surface water runoff. Drainageway 1 is a stormwater swale constructed between 1980 and 1990. All three ditches were constructed in non-hydric soils based on NRCS soil survey and the Wisconsin Wetland Inventory. Based on historic aerial photos, there is no evidence of wetland in the review area prior to ditch construction. The ditches drain only upland based on the delineation report showing upland surrounding all sides. The delineation report noted that no surface water was present in the ditches at time of inspection. Google Earth Street View and aerial photos also do not show the ditches carrying relatively permanent flow. Therefore, these three ditches were constructed in upland, drain only upland, and do not carry relatively permanent flow. These wetlands are considered (b)(3) exclusions of the 2023 Rule, as Amended.

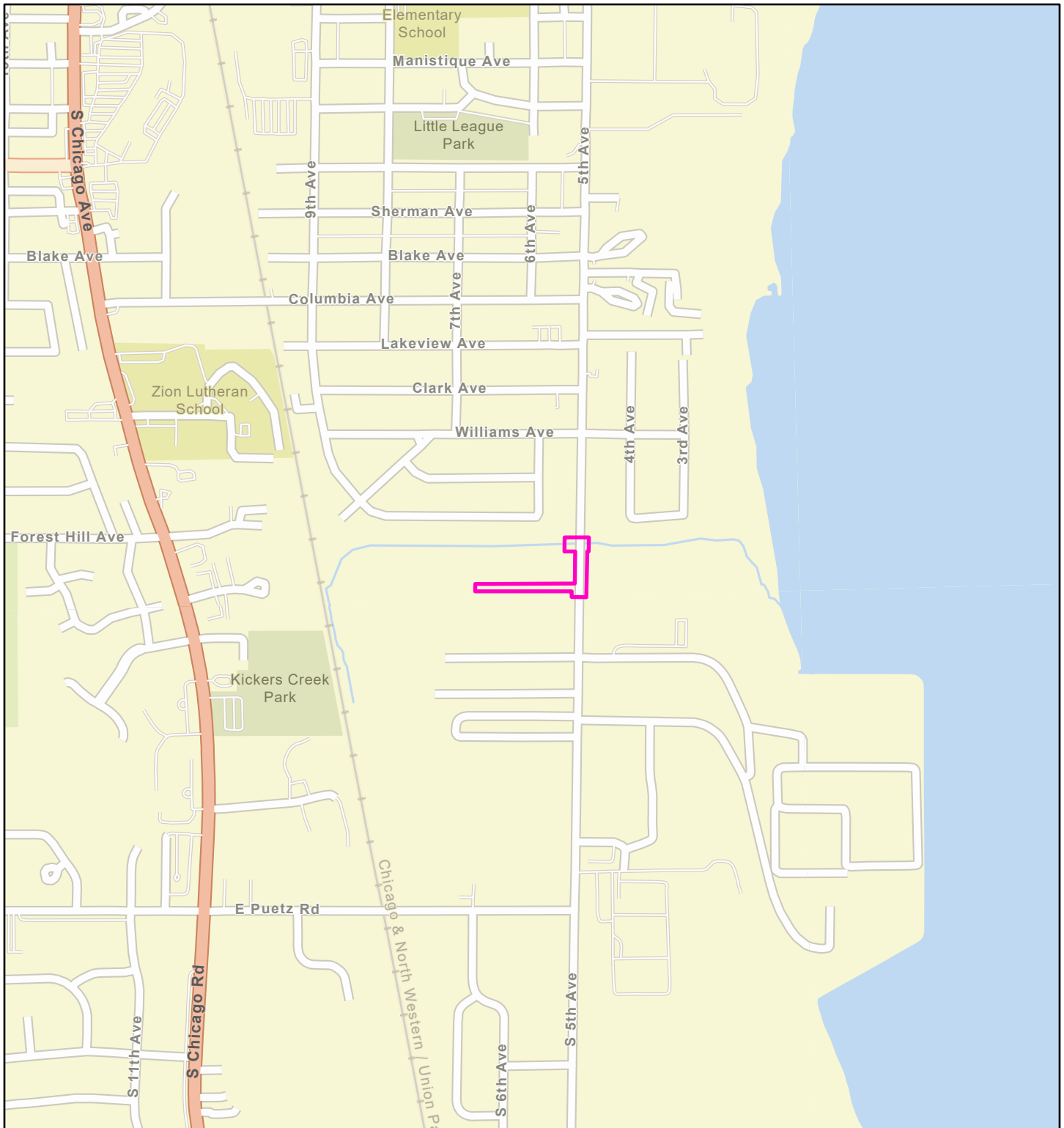

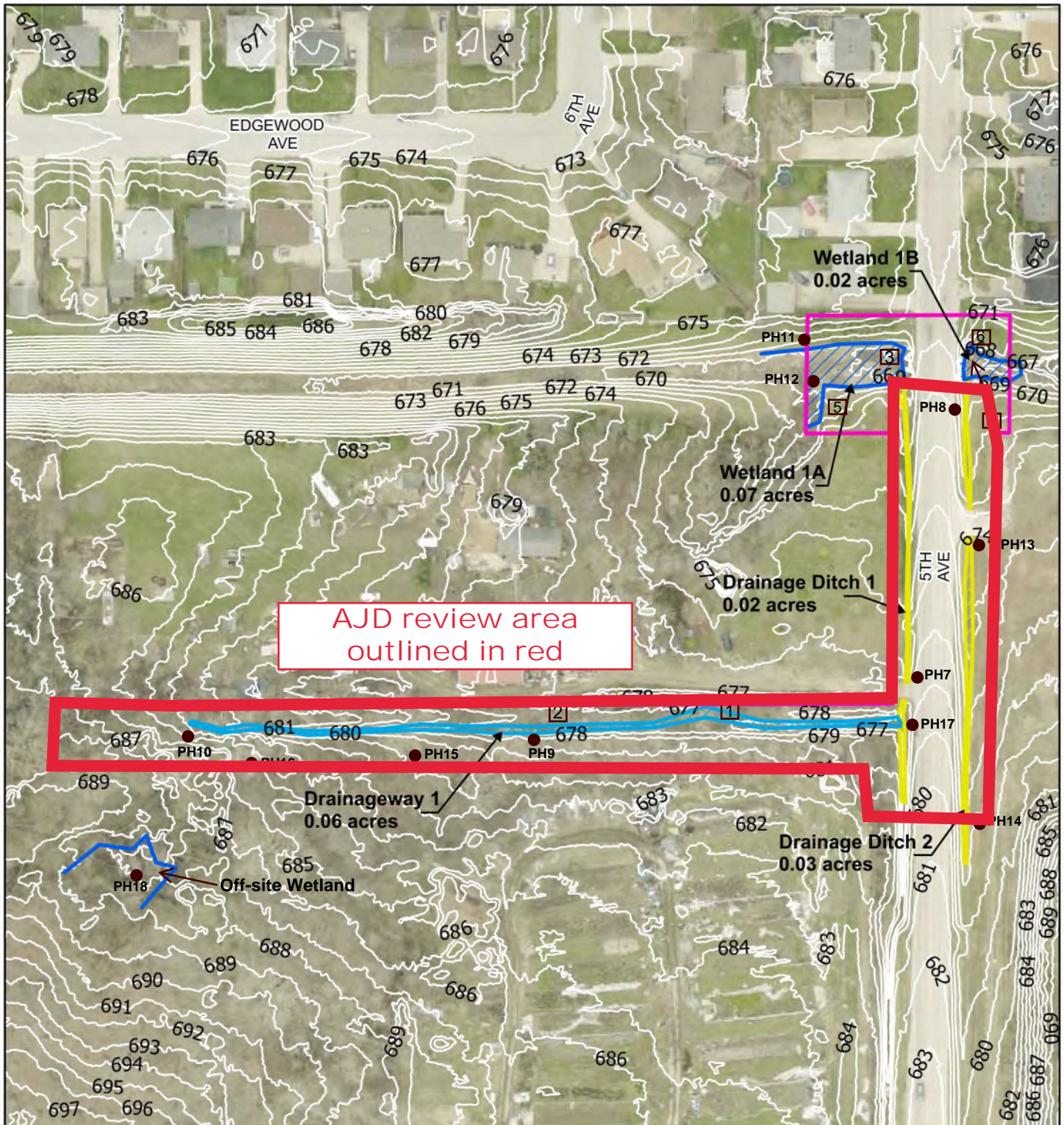
