MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),¹ MVP-2025-00025-KME MFR 1-1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

3. REVIEW AREA. The review area is 5.47 acres and is identified by the polygon on the attached Figure 3. The review area is located in Section 17, Township 25N, Range 1W at the center coordinates (in decimal degrees) of Latitude: 44.652242 and Longitude: -90.525885 in the Town of York, Clark County, Wisconsin. A separate Jurisdictional Determination was completed on February 26, 2025, regarding Wetland 3 which was located directly to the east of this review. Both determinations apply to the same project.

within the review area and describe how it was determined to meet one of the exclusions listed in 33 CFR 328.3(b).⁷

It was determined that Active Clay Borrow Pond (0.48 acres) meets the definition of exclusion b(7) for waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States. The Clay Borrow Pond was confirmed by WDNR staff as an existing WDNR Solid Waste Program-approved clay borrow source, and was formed by a recent clay borrow excavation event. It is located in an area where WDNR has already approved the clay soil for use as lining and capping materials at solid waste landfills in Wisconsin.

A review of the USGS Topo Map, NHD layer, WI 24k Hydro Flowlines Stream Order, USDA Soil Mapping, Wisconsin Wetland Inventory, and aerial imagery also confirmed that the Clay Borrow Pond was excavated within an upland area and no mapped wetlands were identified at this location on the landscape.
