MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),¹ 2025-00062-RJH [MFR 1 of1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not "waters of the United States" even where they otherwise meet the terms of paragraphs (a)(2) through (5). Include the type of excluded aquatic resource or feature, the size of the aquatic resource or feature within the review area and describe how it was determined to meet one of the exclusions listed in 33 CFR 328.3(b).⁹

We have reviewed and evaluated the historical photography, Google Earth photography, soil mapping, and the Wetland Delineation report submitted by the applicant. Wetland 2 is 0.005-acres of wet meadow infested with reed canary grass located within an excavated roadside ditch. Based on evaluation of the available data lack wetland signature in historical aerials, and the lack of hydric soils surrounding the ditch area, we have determined that Wetland 2, is a roadside ditch excavated wholly in and draining only dry land and does not carry a relatively permanent flow of water. Wetland 2 is not jurisdictional under the 2023 Revised Definition of 'Waters of the United States': Conforming' 88 FR 61964 Final Rule.

b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland 3 is 0.507-acres of a wet meadow wetland located within a closed depression in an undeveloped business park lot. The wetland boundary was marked where hydrophytes began to dominate. The change of dominance from Poa pratensis to Poa palustris was distinct. Some cattail has expanded beyond the wetland into areas dominated by upland vegetation. The Digital Elevation Model layer of the National Regulatory Viewer shows that this wetland feature does not have any discrete or confined conveyance features.


Wetland 3 is not a TNW, territorial sea, or interstate water and therefore is not (a)(1) waters. The wetland is depressional, surrounded by uplands. The wetland does not extend to any tributaries and is not drained by any discrete/confined surface water conveyances. The wetland does not physically abut a relatively

permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary and is not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform.

Wetland 3 is approximately 2059 linear feet west of Lake Winnebago and 176 linear feet northeast of an unnamed tributary to Lake Winnebago. There are no diches, swales, pipes, or culverts present within the wetland that connects to downstream jurisdictional waters. Wetland 3 is a non-tidal wetland that does not have a discrete continuous surface water connection to a relatively permanent jurisdictional water and as such does not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, Wetland 3 is not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming' 88 FR 61964 Final Rule.




Lakepark Drive Property Wetland Delineation Map Lakepark Drive Town of Taycheedah Fond du Lac County, WI
