## MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),<sup>1</sup> MVP-2025-00102-MJG, MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>4</sup> the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

The review area is located on the Oak Creek Site project (Parcels #9779003001, #9779002000, and #9779999001) in Section 31, Township 5 North, Range 22 East, Milwaukee County, Wisconsin. (Lat: 42.84905, Long: -87.949382). The review area is surrounded by tree lines, agricultural fields, single family homes, and roadways. There are no other JDs associated with the review area.

a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not "waters of the United States" even where they otherwise meet the terms of paragraphs (a)(2) through (5). Include the type of excluded aquatic resource or feature, the size of the aquatic resource or feature within the review area and describe how it was determined to meet one of the exclusions listed in 33 CFR 328.3(b).<sup>7</sup>

Wetland 1 is a roadside ditch constructed in uplands within the West Elm Road right-of-way (ROW), as reviewed using US Geological Service topographic maps, 3DEP Hillshade, 2-ft Contour, and DEM maps; Wetlands Inventory (WWI) maps; And NRCS soil maps and hydric soils data. NRCS Soil Survey shows silt loam (Ozaukee) soils, with 2-6 percent slopes, and is moderately well drained (partially hydric, 6 percent). Historic aerial imagery shows this area as being frequently farmed, and no wet signatures are visible for this feature prior to 2020. Recent aerial imagery shows Wetland 1 was created during earthwork activities in 2020, when West Elm Road was constructed and when wet signatures became apparent. Based on the desktop resources reviewed, wetland 1 was excavated wholly in and draining only uplands and does not carry a flow of water. Therefore, according to the exclusion (b)(3) of the 2023 rule, as amended, Wetland 1 is not a water of the United States.


b. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the 2023 Rule as amended (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland 2 is not a TNW, territorial sea, or intrastate water, and therefore, is not an (a)(1) water. Wetland 2 does not physically abut a paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. The Wisconsin Wetlands Inventory (WWI), National Hydrography Dataset (NHD), USGS topographic maps, and hillshade do not display Wetland 2 and do not show any tributaries that abut Wetland 2. Based on topographic, hillshade, and elevation modeling mapping, this wetland is a depressional wetland that does not abut a tributary and is surrounded by upland. The closest tributary based off of desktop resources is an unnamed intermittent stream located approximately 250 linear feet east of the review area. Wetland 2 does not abut a relatively permanent water, and as such, cannot be evaluated as (a)(4) adjacent wetland. Therefore,
