MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),<sup>1</sup> MVP-2025-00177-JLK [MFR 1 of 1]<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

## 8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

- a. Wetland 3 is not a TNW, territorial sea, or interstate water and therefore is not an (a)(1) water. Topographic maps, Google Earth Pro aerial imagery, and site photos provided in the delineation report, indicate this wetland is a depressional wetland located in the south/central portion of the review area. Wetland 3 is surrounded by uplands involving an agricultural field in all directions along with a topographically raised agricultural road immediately south and another agricultural access road immediately east of Wetland 3. The wetland within the review area is confined within the previously mentioned agricultural field. Further review of Lidar data and aerial photos via Google Earth Pro indicates there is no confined or discrete hydrological connection such as ditches, swales, pipes, or culverts present that connects Wetland 3 to any other downstream water of the U.S. This wetland does not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary and is not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform.

Historical aerial photos provided in the delineation report indicates the footprint of the reviewed wetland has been in agricultural production since before 1937. The nearest mapped tributary is an unnamed tributary of the Milwaukee River approximately 960 feet east of Wetland 3. There are no ditches, swales, pipes, or culverts that connect Wetland 3 to this or any other downstream jurisdictional water. This wetland is a non-tidal wetland that does not have a continuous surface connection to a relatively permanent jurisdictional water and as such does not meet the definition of adjacent and cannot be evaluated as an (a)(4) adjacent wetland. Therefore, Wetland 3 is not jurisdictional under the 2023

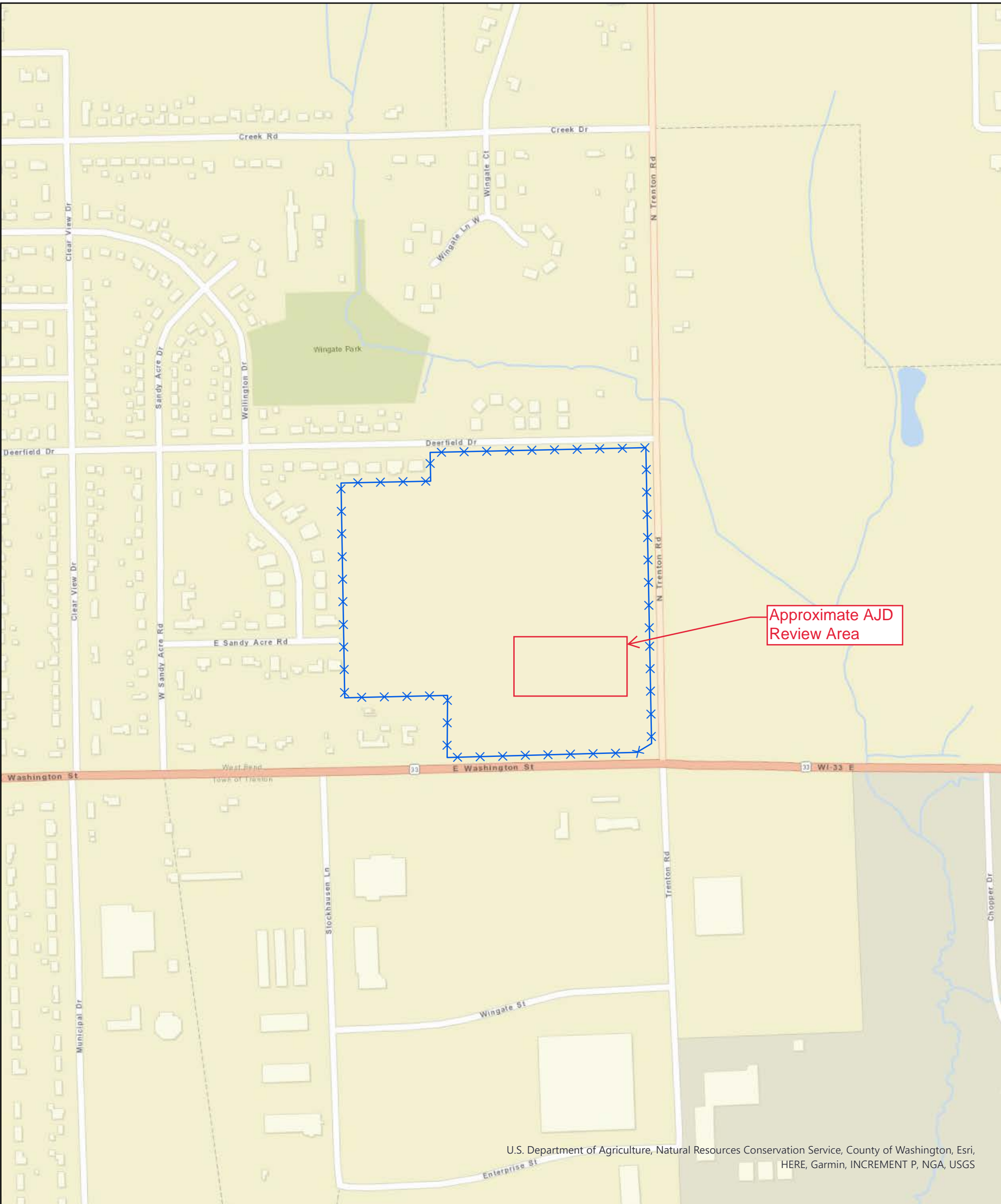

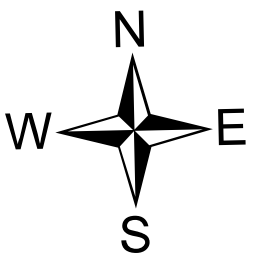

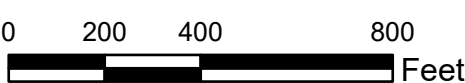
