#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),<sup>1</sup> MVP-2025-00278-CJB, MFR 1 of 1.<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

The review area contains one wetland identified as Wetland 2 on the figure labeled MVP-2025-00278-CJB Figure 2 of 2. Based on the wetland delineation report that was provided with this JD request, this wetland is 0.123 acre in size and is located within an agricultural field. The wetland delineation report described Wetland 2 as being positioned on a side slope containing soil that had previously been placed during the construction of a barn approximately 180 feet to the southwest of Wetland 2. According to the delineation report, sources of Wetland 2's hydrologic inputs mainly consist of rooftop discharge from a nearby structure. The delineation report also stated that Wetland 2 drains into a field drain tile located within the agricultural field. According to the National Regulatory Viewer, a mapped tributary is located approximately 100 feet to the

northeast of Wetland 2; however, based on current aerial photos, LiDAR, and the wetland delineation report, Wetland 2 is surrounded by upland and does not abut or physically touch this mapped tributary or any other aquatic resource.


Based on review of the wetland delineation report, landscape position, aerial photos, and onsite photos, Wetland 2 is not a TNW, territorial sea, or interstate water; therefore, Wetland 2 is not a category (a)(1) water. Wetland 2 is not a tributary and has not been created by impounding a water of the U.S.; therefore, this wetland is not a category (a)(2) or (a)(3) water. This wetland does not directly abut a jurisdictional water identified in paragraph (a)(1), (a)(2), or (a)(3) of the conforming rule. Therefore, Wetland 2 is not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming' 88 FR 61964 Final Rule.


Legend Site Boundary Valley Line Dairy Site Location Map 8976 Sellen Lane Town of Oconto Falls Oconto County, WI
