MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), MVP-2025-01095-ALH [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

[Wetland 1 extends outside of the delineated area to the east and west. To the east, there is a culvert under County Road G near the Paradise Drive intersection. However, there is no indication in recent aerial imagery that there is an Ordinary High-Water Mark through that culvert. Also, there is no indication that there is relatively permanent flow in the ditch east of County Road G and parallel to the south side of Paradise Drive toward Quass Creek. The recent aerial imagery lacks a darkness in the ditch which would indicate water. The National Wetland Inventory layer on the National Regulatory Viewer does not indicate a presence of wetlands where this wetland is located. Multiple years of aerial imagery do not show many changes in the last decade. The Hillshade, Digital Elevation Model (DEM) layer and 2-ft Contours layers confirm the size and shape of the wetland and where it transitions to upland, especially along its southern boundary. The northern and western boundaries of the wetland are restricted by Paradise Drive and other existing development just to the west of the delineated area. It is possible that the wetland extends farther west as a linear ditch next to the south side of the road, but there is no evidence of relatively permanent flow in multiple recent aerial images here either which

is supported by soils that are not hydric in the northwest portion of the delineated wetland. Wetland 1 does not abut a jurisdictional water.

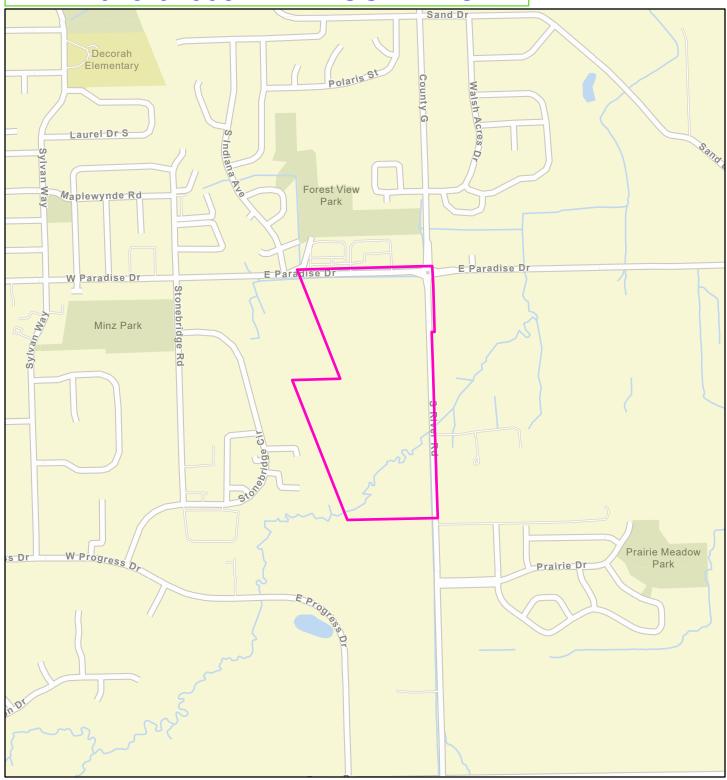
The wetland is not a TNW, territorial sea, or interstate water and therefore is not an (a)(1) water. The wetland does not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. The wetland is a nontidal wetland that does not abut a relatively permanent jurisdictional water and as such does not meet the definition of adjacent and cannot be evaluated as an (a)(4) adjacent wetland; therefore, the wetland is not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming" 88 FR 61964 Final Rule.]

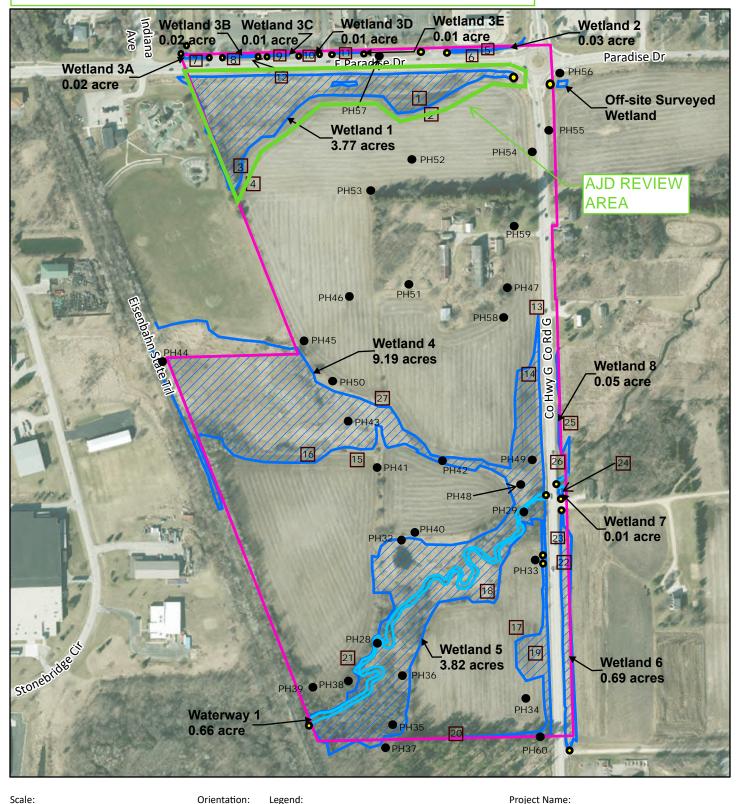
