Explain: **The review areas includes portions of three aquatic features identified as W1, W29, and W24. These features are manmade ditches surrounded by uplands that primarily function as drainage ditches, draining and conveying water away from the subject property. These ditches do not carry a relatively permanent flow of water. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider non-tidal drainage ditches excavated on dry land to be waters of the United States. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are not waters of the United States.**
