Explain: **The review area contains 2 wetlands: Wetland 1 (1.66 acres) and Wetland 2 (0.08 acre). These features are identified as landscape depressions, described as fresh wet meadow wetlands, with no hydrologic connection to another water of the U.S. The boundaries of Wetland 1 and Wetland 2 continue outside of the review area and potential connections were considered. No surface water connection to another jurisdictional feature could be identified through review of aerial photography and Google Street view. The wetlands are not adjacent (bordering, contiguous, or neighboring) to another water of the U.S. and is not separated from another water of the U.S. by man-made dikes or barriers, natural river berms, or beach dunes. The review area is a rapidly developing commercial area and the review area is 1,860 linear feet from the nearest tributary, precluding any ecological interconnection with another jurisdictional water. There is no link to interstate or foreign commerce and the wetlands are not used by interstate or foreign travelers for recreation or other purposes. The wetlands do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not used for industrial purposes. Therefore, the Corps has determined that the subject wetland is isolated and not regulated by the Corps under Section 404 of the Clean Water Act.**

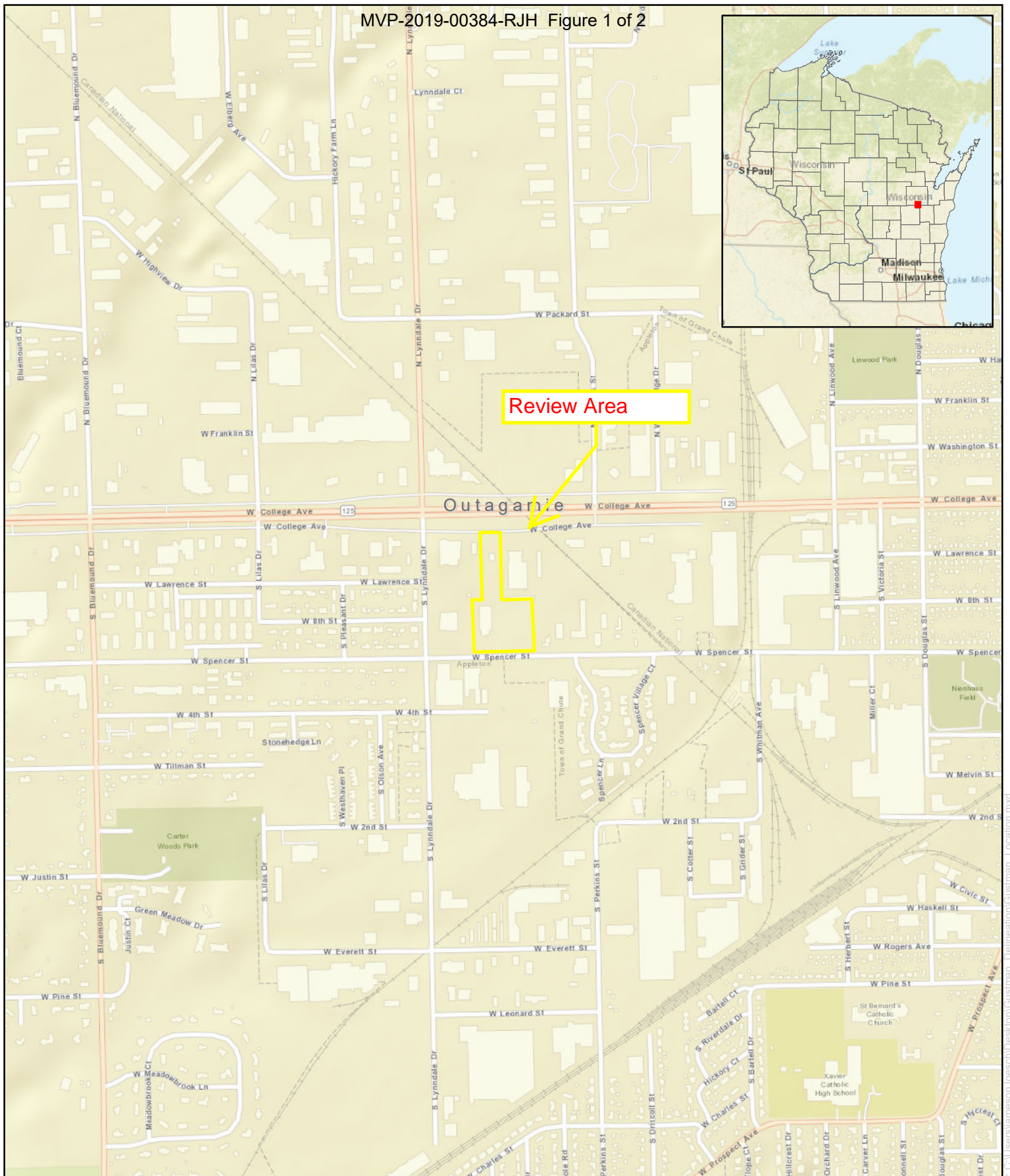
