Explain: **The review area contains one wetland labeled W-1 on the attached figure MVP-2018-03446-AIS Page 2 of 5. This wetland is not bordering, contiguous to, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 2750 feet to the west of W-1. W-1 is a depressional basin surrounded by nonhydryc soils.**

**The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connectons to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W-1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
