Explain: **The review area includes 3 aquatic features identified as Wetland 1 (1.68 acres), Wetland 2 (0.06 acre) and Wetland 3 (0.004 acre). These wetlands were formed in depressions created due to on-site grading associated with work previously authorized by the US Army Corps of Engineers (2005-2632). The authorized work was associated with stream re-location. Wetlands were not previously identified in the review area, which included the area where the current wetlands were identified, prior to the authorized construction. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider water filled depressions created in dry land incidental to construction activity to be Waters of the United States.**
