- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review areas contains two ditches (0.22-acre and 0.31-acre in size) that are not waters of the U.S. This was confirmed by reviewing the Surface Water Data Viewer (SWDV), Google Earth, the 2014 Wetland and Waterways Consulting delineation map, and the 2018 raSmith wetland delineation report. The ditches were constructed between 2015 and 2017 as conveyance features for the adjacent stormwater pond. The ditches are not mapped in the Wisconsin Wetland Inventory of the SWDV, were not delineated in the 2014 Wetland and Waterways Consulting delineation, and do not have a relatively permanent flow of water. The determination of no jurisdiction for the ditches is in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the U.S.; non-tidal drainage and irrigation ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA, which indicates that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are not waters of the United States.**
