with a small drainage area that is landlocked by the adjacent roadways. The depressional basin was created in 2017 and

has no identified inlets or outlets. The wetland does not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. The wetlands are surrounded by farmed uplands, have no swales, pipes or other means to connect it to a water of the U.S. (WOUS). We have determined that this wetland is an isolated depression and not a water of the U.S.

We reviewed available desktop resources such as aerial photography, the flow path information, and stream and wetland mapping to make an approved isolated determination of the wetlands. We determided that the wetland has no hydrologic connection with a Navigable water of the U.S. the wetland does not support an ecological connection to a navigable water.

The wetland does not support a link to interstate or foreign commerce because it is not known to be used by interstate or forgeign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate or foreign commerce. 
