- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains a 0.31-acre drainage ditch created in upland and is not a water of the U.S. This was confirmed by reviewing the 2018 Wetland & Waterway Consulting, LLC wetland delineation report, Milwaukee County aerials, Web Soil Survey, and the Surface Water Data Viewer. The drainage ditch was created in upland between 1985-1990 when the Steinhafel's Furniture development was constructed directly east of the ditch. The ditch does not have a relatively permanent flow of water. The determination of no jurisdiction for the ditch is in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the U.S.; non-tidal drainage and irrigation ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA, which indicates that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are not waters of the United States.**
