SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are **no** "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **The review area contains nine wetlands, labeled Wetland 1, Wetland 2, Wetland 3, Wetland 4, Wetland 5, Wetland 6, Wetland 7, Wetland 8, and Wetland 9 on the attached figure MVP-2015-02800-AIS Page 2 of 5. This determination is valid only for Wetland 1, Wetland 2, Wetland 3, Wetland 4, Wetland 5, and Wetland 9. These wetlands are not bordering, contiguous with, or neighboring another WOUS nor are these aquatic resources separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 750 feet to the northeast of the nearest wetland (Wetland 1). The surrounding soils are all non-hydric. Wetland 9 has a drainage swale to the east, but aerial imagery and topography indicate that it is not connected to the wetland.**

The wetlands located within the review area do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Furthermore, these wetlands are hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and do not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that Wetland 1, Wetland 2, Wetland 3, Wetland 4, Wetland 5, and Wetland 9 are not regulated by the Corps under Section 404 of the Clean Water Act.
