- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetlands 2 - 10 within the review areas shown on the attached map are isolated wetlands and are not considered Waters of the United States. The wetlands were identified in a wetland delineation completed by McMahan Associates, Inc. (McMahan Project B0038-9-16-00595.00). Review of aerial photography (Google Earth 1992-2015) indicates the wetlands are depressional features in an agricultural field that do not have a surface or subsurface connection to any other water. Wetland 10 is associated with a roadside ditch, however, topograph high points north and south of the wetland prevent the conveyance of water from Wetland 10 off site. Topographic maps do not indicate drainage to another water. Wetlands 2-10 do not border, are not neighboring or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Aerial photos also indicate that the wetlands have been consistently disturbed by farming activities and often do not support natural vegetation. The wetlands offer little to no habitat function. There is no ecological connection to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands 2 - 10 are not regulated by the Corps under Section 404 of the Clean Water Act.**
