SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain:

A delineation report was submitted to the Corps documenting the presence of aquatic resources on a 12.36-acre property located in the City of Verona, Dane County, WI. An office review of the delineation report for the subject site was conducted on February 8, 2019 to review the potentially jurisdictional aquatic resources: PH 1 - Wetland 1 (0.02-acre), PH 1 - Wetland 2 (0.15-acre), PH 1 - Wetland 3 (0.01-acre), PH 1 - Wetland 5 (0.01-acre), PH 2 - Wetland 4 (0.05-acre), and PH 2 - Wetland 7 (0.01-acre) as requested by Jeffrey Felland (MSA Professional Services), acting on behalf of the property owner. Although, PH 1 - Wetland 4 (0.33-acres), PH 2 - Wetland 1 (0.06-acre), PH 2 - Wetland 2 (intermittent stream), PH 2 - Wetland 3 (0.16-acre), and PH 2 - Wetland 5 (0.27-acre) were included as part of the delineation report, the applicant has withdrawn their request for an AJD for those wetlands. The Review Area for this Jurisdictional Determination is limited to the boundaries of PH 1 Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7.

A thorough desktop review was conducted to identify any culverts and/or other hydrologic connections within and adjacent to the project site, including both sides of Paoli Street and the entrance ramp to Highway 18. The closest surface water found was an intermittent stream flowing south along the western boundary of the site toward Highway 18 as identified on the USGS topo map. The intermittent stream flows through two culverts beneath the Highway 18 entrance ramps from Paoli Street and ultimately flows into Badger Mill Creek. However, PH 1 - Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7 are located in small depressional areas that do not have a surface or shallow subsurface connection to that intermittent stream. Based upon information gathered as a result of the desktop review and the wetland delineation report, Corps staff determined that the six wetlands (PH 1 - Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7) are wholly surrounded by uplands and lack an unbroken surface or shallow sub-surface

connection to a water of the United States. PH 1 - Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7 have no physical separations by man-made dikes or barriers, natural river berms, beach dunes, and the like from jurisdictional waters. The surrounding land use comprised of agricultural, commercial, and transportation uses do not provide cover or habitat between the wetlands and other aquatic resources. These wetlands do not have an ecological connection to a WOUS due to the lack of ecological resources and distance between the wetlands and the nearest tributary.

The waterbodies described above, PH 1 - Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7 do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; they do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and they are not known to be used for industrial purposes for interstate or foreign commerce. PH 1 - Wetlands 1-3 and 5 and PH 2 - Wetlands 4 and 7 have been determined to be non-jurisdictional under the Clean Water Act because the wetlands lack connections and/or relationships sufficient to serve as a basis for jurisdiction.
