Explain: **The review area contains one wetland, labeled Wetland Area 1 on the attached figure MVP-2018-03480-AIS Page 2 of 5. The figure also contains an area labeled Wetland Area 2, but this area appears to be connected to Wetland Area 1 outside the limits of the project area and as such will be considered part of the same wetland. This wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 2,000 feet to the east of the wetland. The location of the wetland is influenced by the quarry to the west, but the hydric soils in the area indicate that the wetland is not an artefact of construction.**

**The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that Wetland Area 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
