Explain: **The review area contains 1 intrastate wetland, W-1. This wetland was previously determined to be an isolated aquatic resource not subject to Corps jurisdiction (MVP-2013-01956-MHK). Site conditions remain the same since the previous approved jurisdictional determination and 2013 Corps site visit. This is a small depressional area with no surface or shallow subsurface connection to the Menomonee River, approximately 2,142 feet to the east. There are no surface inlets/outlets in or nearby the wetland. There are no ditches along Flint Drive. This wetland does not border, neighbor nor is contiguous with another water of the U.S. It is not separated from other WOUS by man-made dikes, barriers, or berms. This wetland is surrounded by commercial development and highways. The disturbance of surrounding land uses precludes an ecological connection to a WOUS.**

This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that this wetland is not regulated by the Corps under Section 404 of the Clean Water Act.
