Wetlands 8, 9, and 10 are wetlands that formed in depressions created due to on-site grading, topsoil stripping, and the installation of sewer and water associated with initial development activities that occurred in 2004. Explain: **The review area contains 1 wetland: Wetland 6 (102,992 square feet) is identified as a disturbed or farmed wet meadow wetland located in a topographic depressions with no hydrologic connection to another water of the U.S. Wetland 6 is not adjacent (bordering, contiguous, or neighboring) to another water of the U.S. and not separated from another water of the U.S. by man-made dikes or barriers, natural river berms, or beach dunes. The review area is approximately 120 linear feet from the nearest tributary in an active agricultural area precluding any ecological interconnection with another jurisdictional water. There is no link to interstate or foreign commerce and the wetlands are not used by interstate or foreign travelers for recreation or other purposes. The wetland does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not used for industrial purposes. Therefore, the Corps has determined that the subject wetland is isolated and not regulated by the Corps under Section 404 of the Clean Water Act.**
