- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Based on information provided by the applicant and a recent delineation report, the Corps has determined that wetlands 6, 8, and 9 identified on figure "MVP-2018-03709-RJH Figure 1 of 2" and wetland 2 identified on figure "MVP-2018-03709-RJH Figure 2 of 2" were excavated wholly in and drain dry land only. These features are manmade ditches surrounded by uplands that primarily function as agricultural drainage ditches, draining and conveying water away from the subject property. These ditches do not carry a relatively permanent flow of water. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider non-tidal drainage ditches excavated in dry land to be waters of the United States. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in *Rapnaos v. U.S.* and *Carabell v. U.S.* issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are not waters of the United States.**
